RESIDENTIAL PLAN REVIEW PARTIAL PERMIT PROCESS

PURPOSE

As a customer service initiative, the Development Services Department (DSD) created this Information Bulletin (IB) 202 to inform internal and external customers of the residential partial permit process. This new business process is intended to allow applicants to request a partial approval for qualifying projects. This new process will be effective October 1st, 2022.

SCOPE

Customers seeking to begin construction while certain conditions are being met and prior to the full permit being issued may request the Building Official to issue a partial foundation permit. This will allow the construction to commence while pending plan review corrections are resubmitted by the applicant. Partial permits may only be applied for after and the first round of building and zoning reviews have been completed.

Applicants must submit the request in writing using the Residential Partial Permit Application Form and submit to biresidential@dallascityhall.com. The application must be signed by the applicant and counter signed by the owner. DSD staff will process requests within three (3) calendar days.

All permit fees will be collected when the partial permit is issued and no additional fee for processing will be charged for the issuance of a foundation permit. The work commenced by the applicant will be at the owner's own risk. Vertical construction inspections will not be generated or performed until the full permit is issued. Any work that is commenced and is not part of the partial permit scope of work will be considered, "Work Without Permit". Contractors exceeding the partial permit scope of work man be subject to administrative penalties and suspension/revocation of their certificate of registration.

A partial foundation permit will allow the applicant to commence with site work, private utility, basement excavation, foundation and footing installation.

The following items are examples of when a partial foundation permit may be issued:

- Project is missing minor information on design plans
- Minor denial comments have not been resubmitted
- Missing minor documentation, forms, and letters

• Other non-building or fire related denial comments

The following items are examples that may prevent the issuance of a foundation permit:

- Property is not platted or early release is not on file
- Missing survey or noncompliant setbacks/easement encroachments
- Area footprint exceeds maximum allowances
- Missing foundation and retaining wall structural drawings
- Project is in a floodplain overlay
- Any life/safety building or fire related denial comment that has not been resolved

Upon the issuance of a partial foundation permit, City staff will notify the applicant and insert specific comments in the permit application and generate the applicable inspections associated with site, utility, and foundation requests. Partial permits will expire after 90 days of inactivity on the project site or when a good-faith effort to correct pending permit issues is not demonstrated by the applicant.

SUMMARY
