

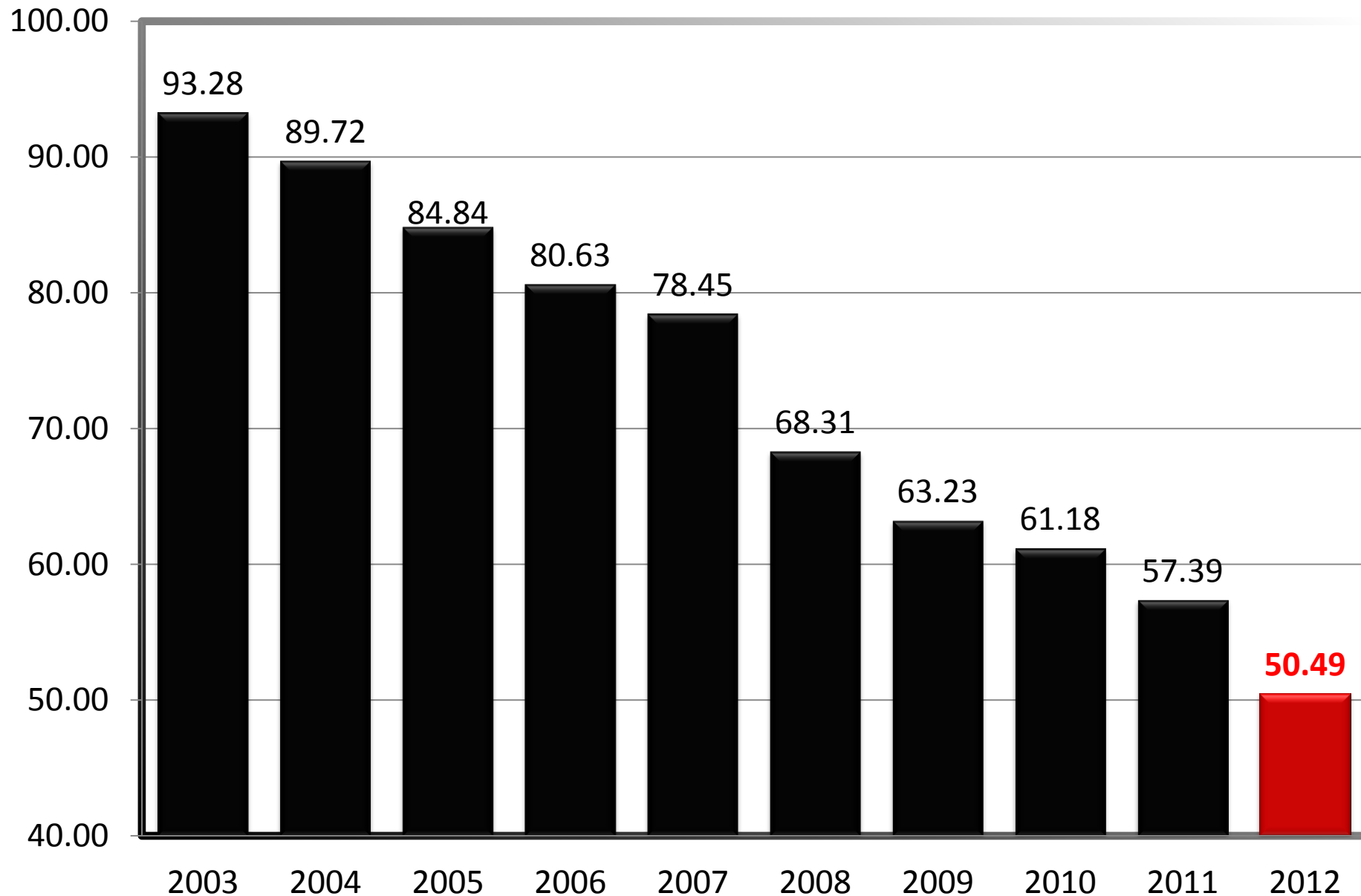

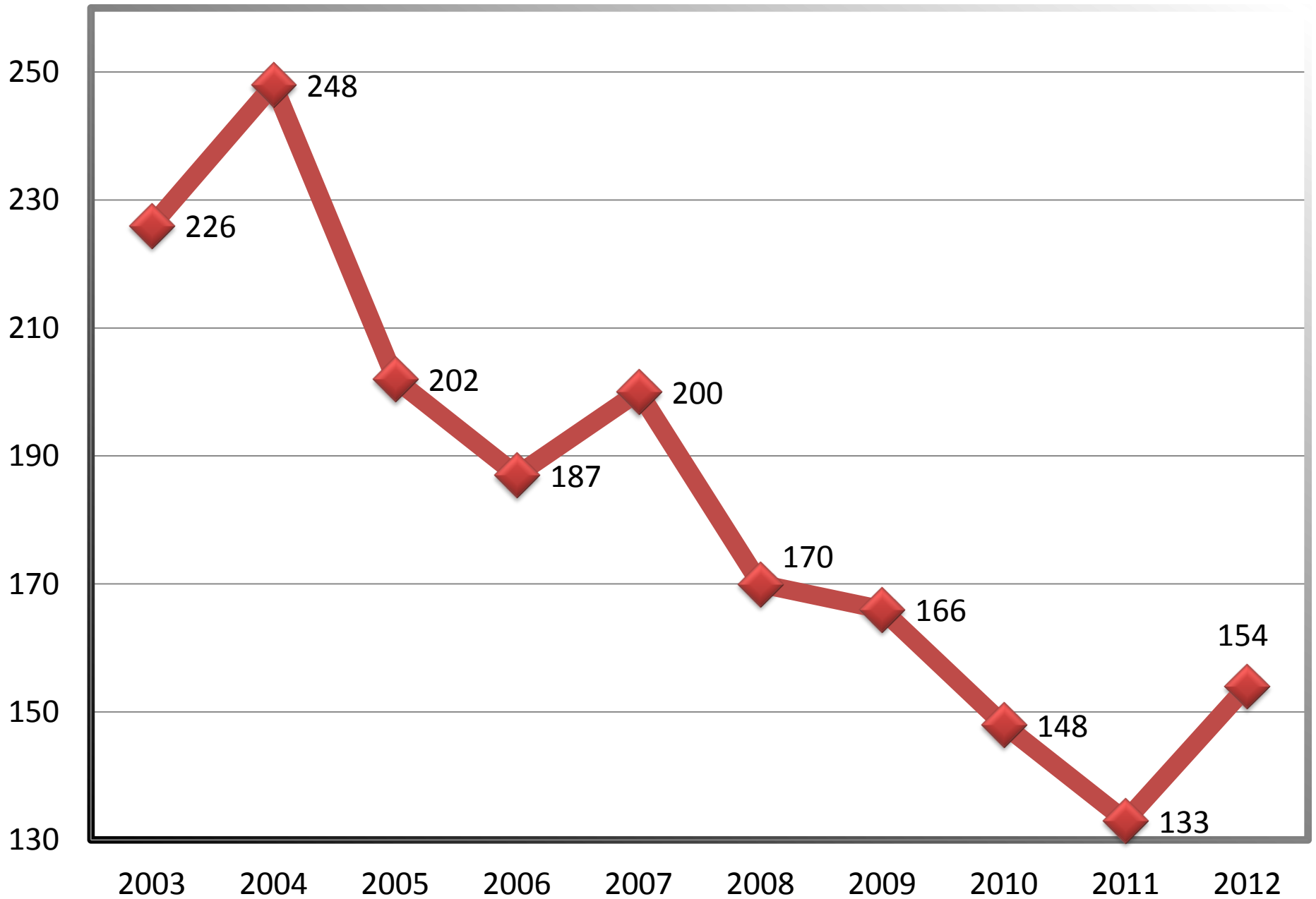
City of Dallas Overall Part 1 Crime Rates 2003 - 2012

The lowest overall Crime Rate since 1966



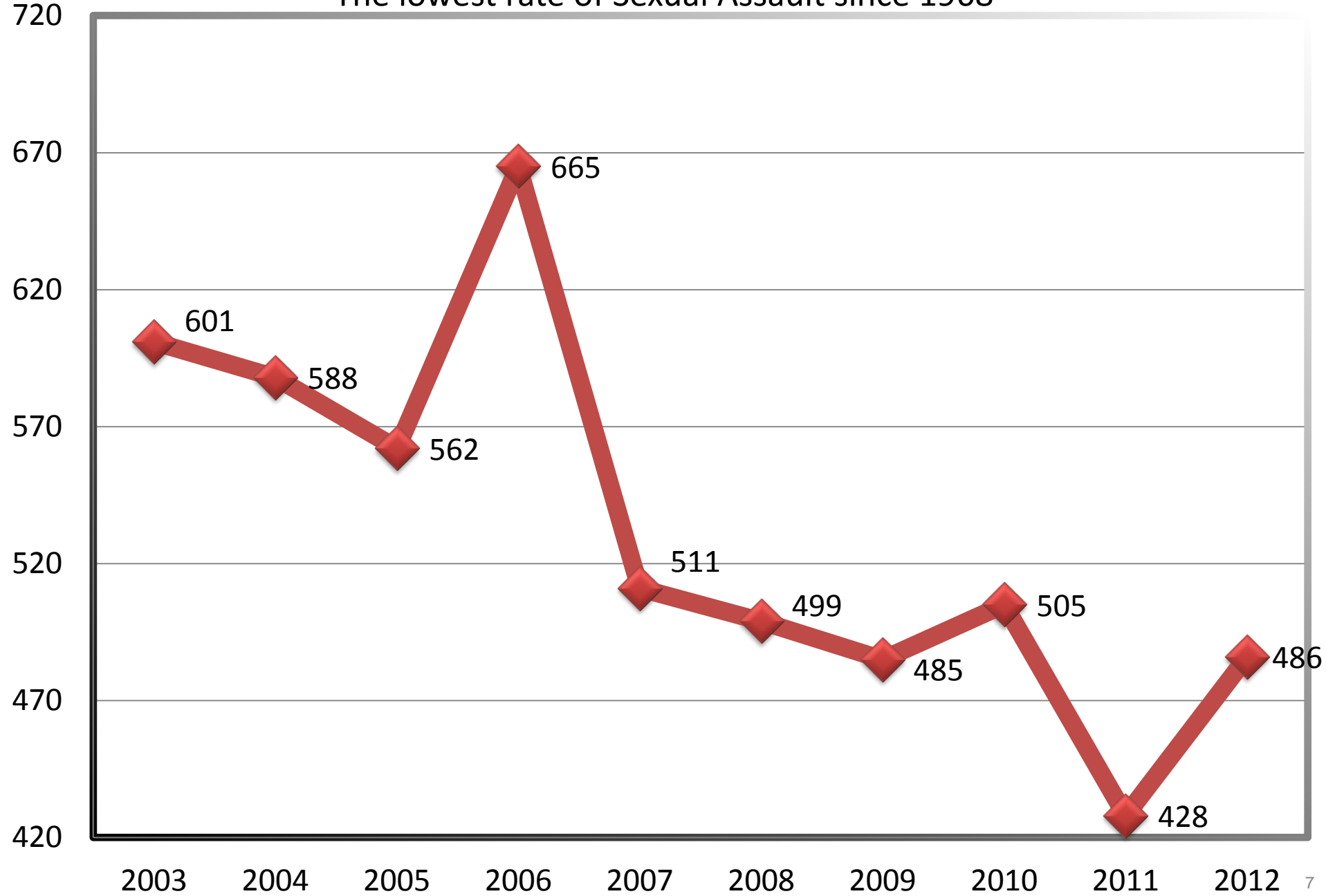
City of Dallas Murder Offense Count 2003-2012

The lowest Murder Rate since 1958



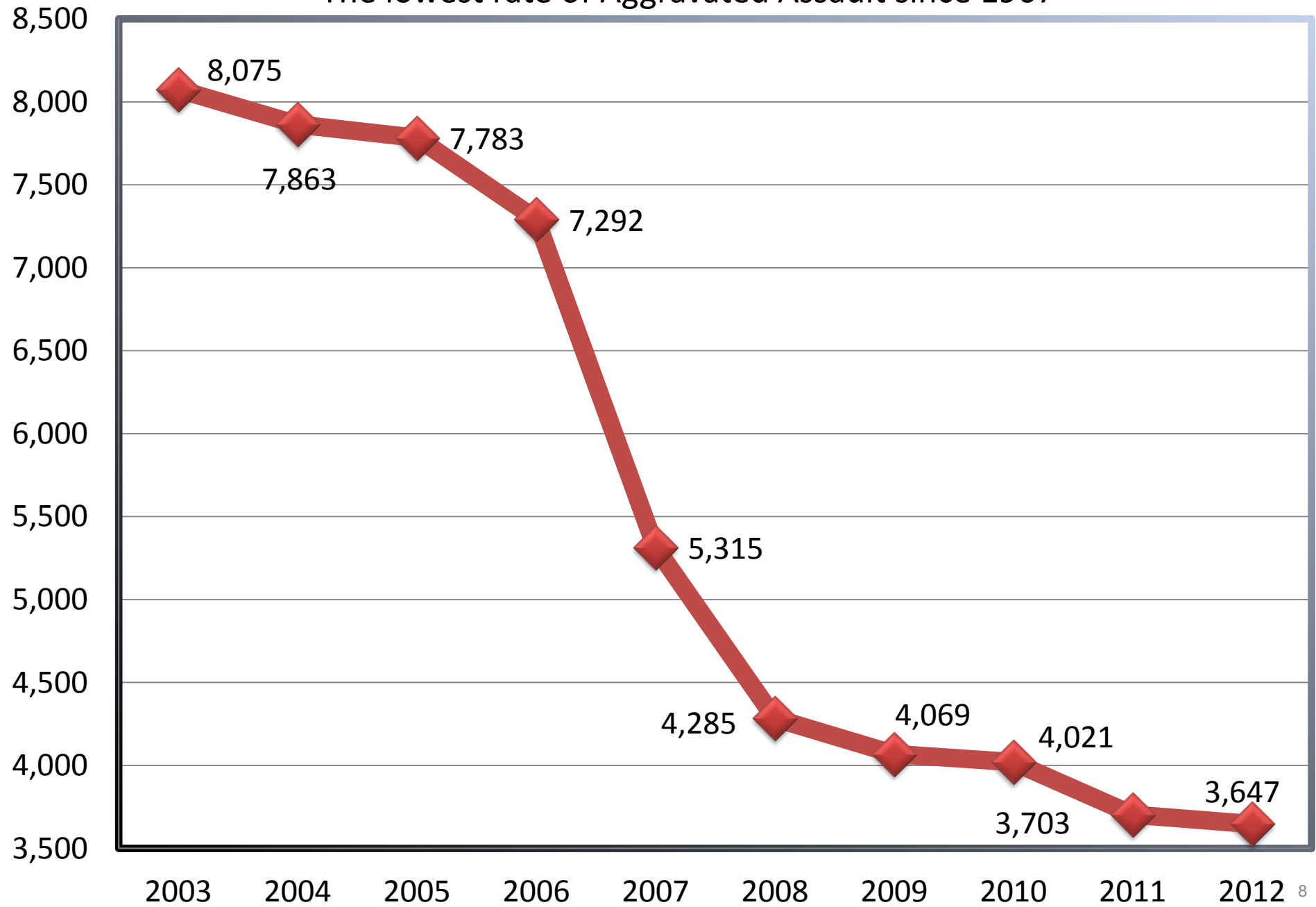
City of Dallas Sexual Assault Offense Count 2003-2012

The lowest rate of Sexual Assault since 1968



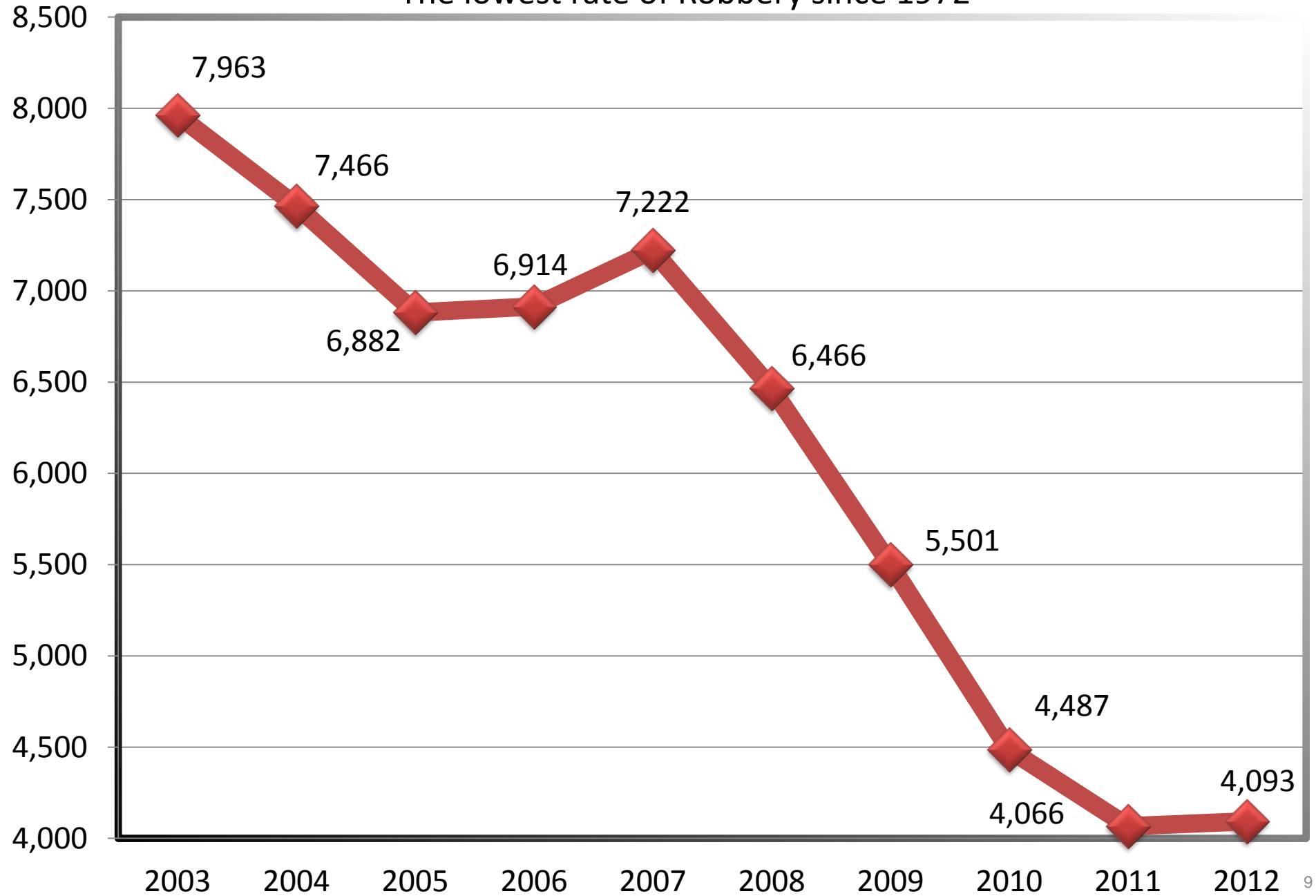
City of Dallas Aggravated Assault Offense Count 2003-2012

The lowest rate of Aggravated Assault since 1967



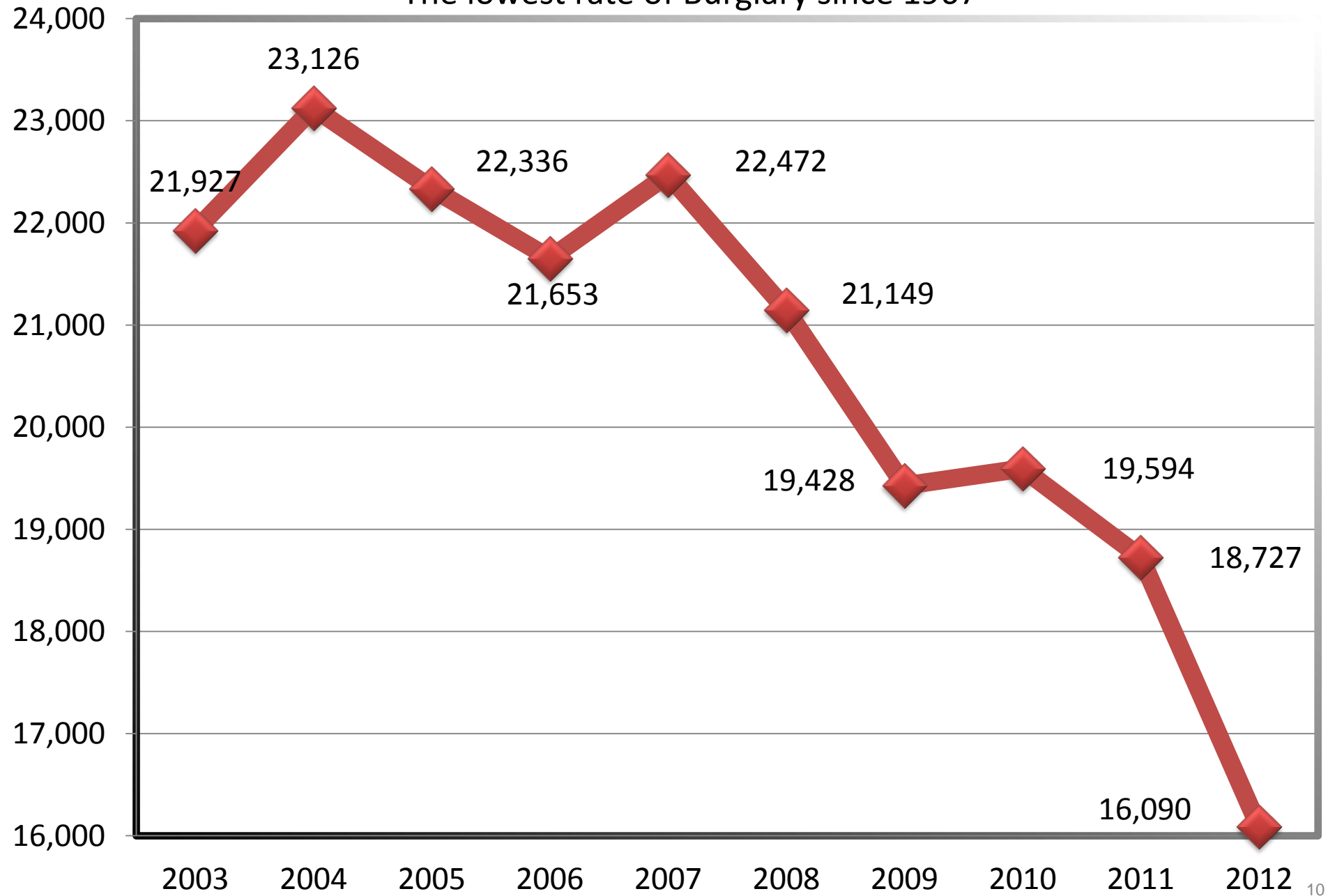
City of Dallas Robbery Offense Count 2003 - 2012

The lowest rate of Robbery since 1972



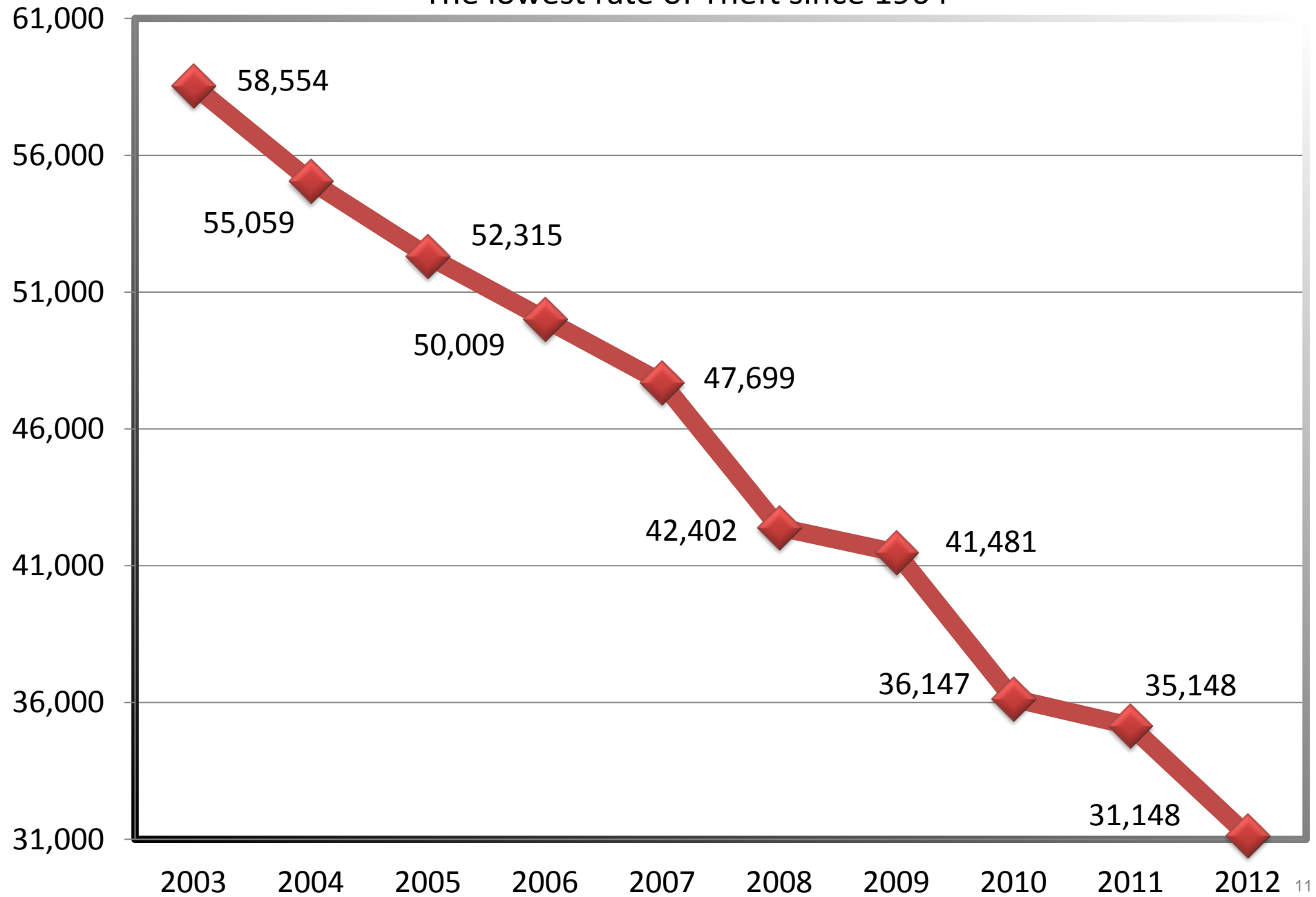
City of Dallas Burglary Offense Count 2003 - 2012

The lowest rate of Burglary since 1967



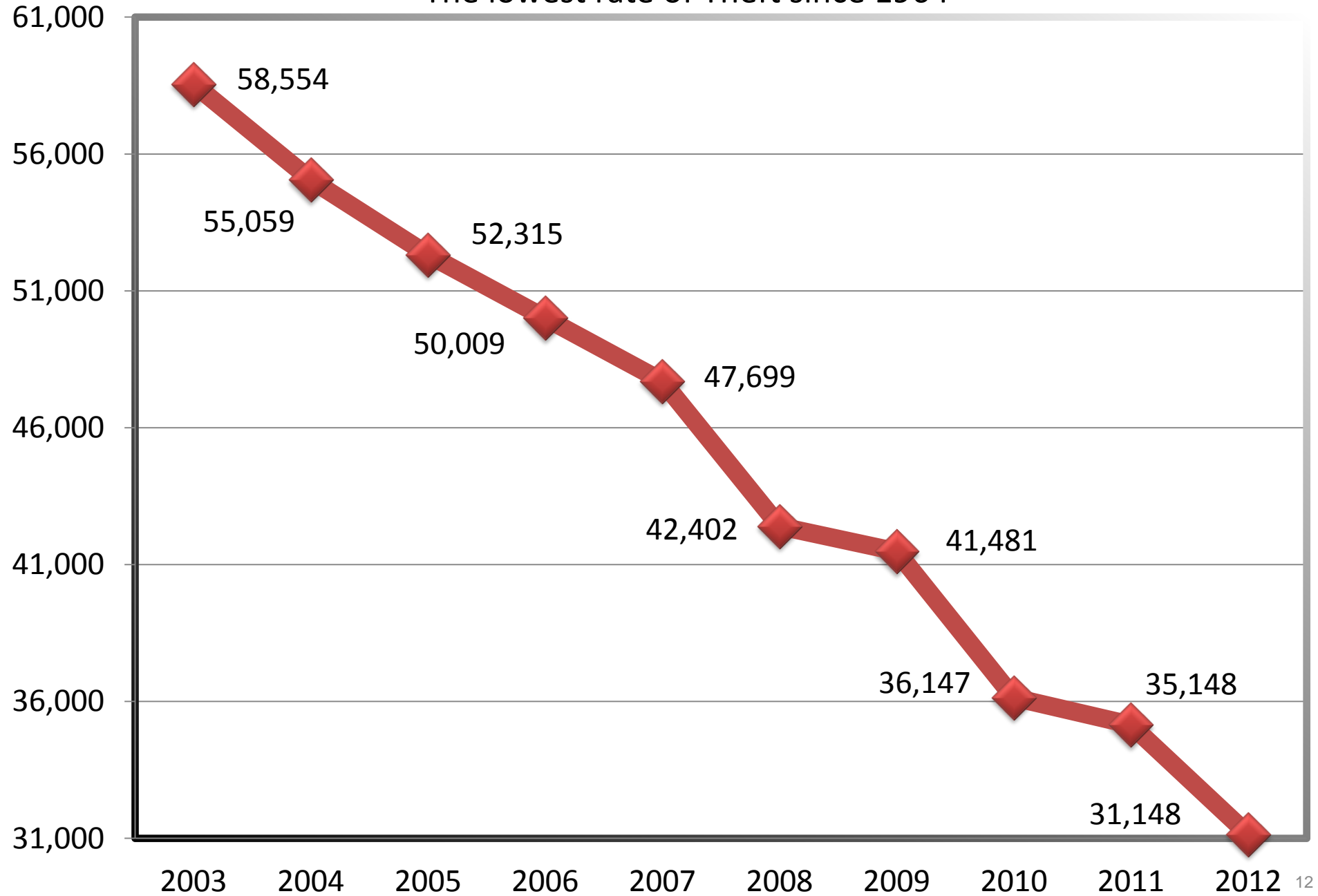
City of Dallas Theft Offense Count 2003 - 2012



Purpose

The purpose of today's briefing is to define the role and job function of the Dallas Police Department's Child Abuse Unit

Goals

- Provide a coordinated multidisciplinary approach to the investigation, prosecution, and treatment of child abuse cases
- Use multidisciplinary team approach to investigate cases by housing partner agencies under one roof
- Actively promote child abuse education and awareness



Goals

- To complete a thorough investigation into offenses that occur against children
- Obtain and share pertinent information with Child Protective Services
- Obtain medical data that will assist in the investigation and prosecution of crimes against children
- Provide services such as therapy, counseling, transportation, supplies, and any other resources available to assist families through the Dallas Children's Advocacy Center (DCAC)

Dallas Children's Advocacy Center

- History of DCAC
 - Created in 1991
 - 2nd Children's Advocacy Center in the state of Texas
 - 1 of 66 Children's Advocacy Centers in Texas; 1 of 750 nationwide
 - Served over 30,000 children and families
 - Relocated to new location in January 2013
 - Former Location: 14,000 sq ft
 - New Location 56,000 sq ft

Dallas Children's Advocacy Center

- DCAC provides a warm, child-friendly environment to help children who are referred by law enforcement or CPS
- Our average client is a 10 year-old girl, sexually abused by someone she knows and trusts
- A specially-trained DCAC forensic interviewer listens to the child's story and ask non-leading questions as the child talks about the trauma he /she has experienced
 - Because the child does not have to interact with or be interviewed by multiple professionals, this reduces trauma for the child and provides for a much stronger case if the case goes to court



Forensic Interview Room

Dallas Children's Advocacy Center

 - Age criteria
 - Children 0 to 17 years of age at the time of offense/incident
 - Any adult persons mentally or developmentally disabled
 - Types of interviews
 - Sexual abuse
 - Severe physical abuse
 - Witness to homicide or a violent crime
 - Child abductions

Dallas Children's Advocacy Center

- The DCAC brings together the team of specialized professionals
 - Investigates child abuse cases and prosecutes offenders
 - Provides therapy for child victims

Dallas Children's Advocacy Center

- DCAC provides the following services:
 - Multi-disciplinary case review
 - Ensures that these delicate cases proceed in the best interest of the child victim
 - Child abuse cases in Dallas County
 - Forensic Interview Program
 - Ensures that a possible child victim has an opportunity to tell his/her story to an unbiased professional
 - Other professionals who may investigate and prosecute cases against alleged perpetrators observe the interview
 - This both reduces trauma to the child and allows for a legally-defendable interview should the case proceed through the legal system

Dallas Children's Advocacy Center

- DCAC's Therapy Program
 - Clients receive specialized treatment to move beyond the role of victim
 - Goal is to lead to a healthy and happy life
- DCAC Family Assistance Program
 - Provides support, information, referrals and resources to victims and their families
- The DCAC Education Program
 - Educates the community in the detection, investigation and treatment of child abuse
 - International influence through hosting the Crimes Against Children's Conference:
 - The largest conference training front-line professionals who work with child abuse cases daily such as FBI, law enforcement, CPS, prosecutors, and therapists

Investigative Responsibilities

- The Child Abuse Squad is responsible for all sexual assault and physical injury offenses including:
 - Death
 - When the victim is a juvenile and the suspect is a
 - Family member
 - Guardian
 - Household member
 - Or any person who has legal control or responsibility for the safety of the child for any period of time



Operation Brick and Mortar Internet Facilitated Child Sex Trafficking Public Safety Committee September 23, 2013



Purpose

- Explain how technology, Internet and cell phones, have changed the face and landscape of Sex Trafficking.
 - Moved from a localized street level or Sexually Oriented Business (SOB), to a virtual environment
 - Operate in the City of Dallas with intangible boundaries/locations
 - Traditional enforcement techniques less effective

Goals and Objectives

- Leverage technology to establish a clear presence on the Internet to:
 - Reduce offenses
 - Identify and locate child and adult victims of sex trafficking
 - Deter and disrupt criminal conduct
 - Remove perceived anonymity for those who:
 - ◆ Post ads for prostitution
 - ◆ Respond to ads for prostitution “Johns”
 - Sustainable

Technology Facilitated Trafficking

- Game Changer
 - Availability of technology
 - Crosses social and economic lines
 - New points of contact
 - Recruitment
 - Internet sites
 - Social networking sites
 - Chat lines
 - Advertisement
 - Delivery

Technology Facilitated Trafficking

- Game Changer
 - Perceived anonymity of users
 - Traffickers, Buyers, “Johns” and Posters
 - All done online, phone, only exposure is walking to hotel room
 - Provides platform to disguise as:
 - Legitimate
 - Enables the old to look younger, young look older
 - Hide child victims
 - » Portray children as adults

Technology Facilitated Trafficking

- Investigative/Enforcement Challenges
 - Identifying/locating children
 - Who is in the picture
 - **Is it a real person?**
 - Prepaid phones, credit cards
 - Volume
 - **Dates/meetings**
 - **Staffing / Safety**

SUBJECT: Authorize a supplemental agreement No. 1 to extend service contract for firefighter's wellness physical examinations and fitness assessments

Supplemental Agreement No. 1 (1) extends the service contract through December 31, 2013 with HealthTexas Provider Network dba MedProvider for medical examinations and fitness assessments for firefighters, and (2) an increase of funds to the service contract, in the amount of \$456,983, from \$782,977 to \$1,239,960– Not to exceed \$456,983 (subject to annual appropriations).

The extension to the service contract will allow firefighters in Battalions 1 through 3 to receive medical examinations and fitness assessments while comprehensive specifications incorporating new 2013 edition standards are being developed for a competitive proposal process. The new contract that will be secured after the competitive proposal process is targeted for City Council approval in December 2013.

Due to sudden increase in physical activity while responding to emergencies, firefighters are twice as likely as the average person to suffer cardiac problems, including sudden cardiac arrest. Cardiac arrest is the number one reason listed in Line of Duty Death reports for firefighters nationally. Firefighters are also exposed to a variety of chemicals and harmful substances such as carbon monoxide, hydrogen cyanide, acrolein, benzene and hydrogen chloride. These substances are commonly found in smoke. Dallas Fire-Rescue (DFR) follows the standards set by the National Fire Prevention Association (NFPA) is ensuring that all the firefighters receive timely physical examinations and fitness assessments to detect preventable fatalities. The medical examination results are provided only to firefighters to follow up with their physicians. The department only receives the notification of the firefighter as fit, conditionally fit or not fit to return to duty.

The City is seeking recommendation from the Public Safety Committee to authorize this service contract extension for the firefighters' wellness physicals and fitness assessments. This item will be placed on the City Council Addendum on September 25, 2013.

SUBJECT: Acceptance of the FY2013 Edward Byrne Memorial Justice Assistance Grant (JAG)

On May 30, 2013, the Bureau of Justice Assistance (BJA) announced funding allocations for the Edward Byrne Justice Assistance Grant (JAG) for the 2013 award year. The JAG program is the primary provider of federal criminal justice funding to state and local jurisdictions.

As designated recipients of this funding, the City of Dallas and other eligible disparate jurisdictions within Dallas County have been awarded \$932,597. The City of Dallas has historically served as the regional fiscal agent for the funds. For 2013 \$410,449.27 has been awarded to Dallas County and cities, including, Balch Springs, Carrollton, DeSoto, Duncanville, Garland, Grand Prairie, Irving, Mesquite and Richardson. **The City of Dallas' portion of this funding is \$522,147.73, including Management and Administration totaling \$93,259.70. The remainder of the funds will be allocated as follows; \$400,000 will fund Community Prosecution and \$28,888.03 will fund computers for the City of Dallas Police Department.**

The JAG program supports a broad range of activities that prevent and control crime, and which improve the criminal justice system. In past years, the City of Dallas has used these funds to expand camera surveillance in high crime areas of the City; improve interoperable communications with in-car video systems and radio equipment for the Police Department and support Computer Aided Dispatch. In 2012, the Community Prosecution Team was able to inspect and evaluate structures throughout the City of Dallas in order to create a list of properties that would be suitable for the Texas National Guard's Operation Crackdown program.

The City is seeking recommendation from the Public Safety Committee to accept the FY2013 Edward Byrne Justice Assistance Grant. This item will be placed on the City Council Agenda on September 25, 2013.

SUBJECT: Acceptance of the City of Dallas NIBIN Program Grant

The Criminal Justice Division of the Office of the Governor has awarded \$ 80,000 for the National Integrated Ballistics Information Network (NIBIN) program to the Dallas Police Department for the period September 1, 2013 through August 31, 2014 to partially fund one sworn officer for the performance of NIBIN duties.

The NIBIN program is administrated by the Bureau of Alcohol, Tobacco, Firearms, and Explosives (ATF) for federal, state and local law enforcement agency partners. Forensically trained personnel enter digital images of the markings made on recovered spent cartridge casings from fired weapons, providing a link to criminal offenses. The images are correlated and searched in local, regional and national databases; potential matches are confirmed by a forensic specialist and the intelligence is provided to detectives in a timely manner. To date, the Dallas Police Department's NIBIN Team has acquisitioned about 24,000 casing images and made 566 case identifications.

The City is seeking recommendation from the Public Safety Committee for the acceptance of the FY 2013-2014 NIBIN Program grant from the Office of the Governor. This item will be placed on the City Council Agenda on October 8, 2013.

Upon completion of a formal competitive proposal process, the City seeks authorization to initiate a three-year master agreement for riot gear and accessories totaling \$487,154 with the most responsive bidders Galls, LLC in the amount of \$215,316 and GT Distributors in the amount of \$271,838.

This master agreement will provide officers with riot gear and accessories to protect themselves and the citizens of Dallas when responding to critical incidents or events that could become volatile. SUBJECT: Acceptance of the FY2013-2014 Texas Department of Transportation Comprehensive STEP Grant

The Texas Department of Transportation has awarded \$999,999 for the Comprehensive STEP (Selective Traffic Enforcement Program) Grant to the Traffic Section of the Dallas Police Department for FY 2013-14. The grant requires a match of \$273,383 from the City of Dallas for pension contributions and in-kind contributions of \$14,415 for federal insurance cost. The grant provides for the reimbursement of travel expenses and overtime salaries for officers and supervisors to take enforcement action on specific violations: driving while intoxicated, speeding, occupant restraint and disregarding traffic control devices in the City of Dallas.

The grant funds provided by the Texas Department of Transportation originated with the National Highway Traffic Safety Administration and are intended for the reduction of injury and fatality crashes. The major contributors to fatal crashes are alcohol use, non-use of occupant restraints, speeding and disregarding traffic control devices. The Traffic Section of the Dallas Police Department has utilized grant funding as part of its overall traffic safety plan for many years.

The City is seeking recommendation from the Public Safety Committee for acceptance of the FY2013-2014 Texas Department of Transportation, Comprehensive STEP grant. This item has been placed on the on the City Council Agenda on September 25, 2013.


SUBJECT: Authorize a Three-Year Master Agreement for Tasers

The City seeks authorization to initiate a three-year master agreement for tasers and accessories totaling \$947,132 with Taser International, Inc, a sole source.

This master agreement will provide Taser X26 non-lethal weapons and accessories to the Police Department. The Taser X26 technology is an additional tool that gives officers an advantage when confronted with a situation where an offender becomes combative and non-responsive to verbal commands or becomes a danger to himself, the officer, and citizens. The Taser X26 allows the officer to gain control of the offender from a safe distance thus reducing the risk of injury to the offender, officer and citizens.

Currently the Police Department provides issuance at the divisional level, supplying cartridges, batteries, other replacement parts and training as needed. The department has two trainers at the academy who are qualified to provide training.

The City is seeking recommendation from the Public Safety Committee to authorize this master agreement for the purchase of tasers. This item will be placed on the City Council Agenda on October 23, 2013.

SUBJECT: Authorize a Memorandum of Understanding with Dallas County for participation in the Urban Counties TechShare.Juvenile Program

In 2007 Dallas County entered into a collaborative partnership with the Texas Conference of Urban Counties to develop an integrated information management system to share information on juvenile case management with participating local governments. Dallas County then administered the development of Juvenile Information System (JIS). This program allowed juvenile cases to be filed electronically and the ability to perform statewide searches with local governments. Dallas County is now working to retire JIS and transition to TechShare.Juvenile, which is the extended case management system and will give participating agencies the ability to see information regarding juveniles statewide. Law Enforcement Agencies, County Agencies, Municipal Courts, and School Districts benefits from the system include: viewing juvenile information across the State and sharing attachments; creating photo line-ups; administering and tracking First Offender Programs; and generating reports. The electronic cases can be transferred to Internal Departments and External Law Enforcement Agencies for recording and tracking warrant; supplying municipal court offense history, notifying of arrests and disposition, and identifying new enrollees on probation.

Currently, the Juvenile Information Sharing Case Management System has almost 5,000 users with approximately 3,585 of those being Dallas Police Officers. When TechShare.Juvenile goes into effect in November 2013, 79 additional counties will be participating and the program will be rolled out to all counties by 2015. This program has allowed the Police Department to function more efficiently when dealing with juvenile offenders. The MOU outlines what is required by Dallas Police Department to utilize the system. The new system will do everything the current system is capable of doing, but it has been upgraded and has expanded the capabilities of sharing of information with other Law Enforcement Agencies, County Agencies, Municipal Courts, and School Districts.

The City is seeking recommendation from the Public Safety Committee to authorize the TechShare.Juvenile Memorandum of Understanding. This item will be placed on the City Council Agenda on September 25, 2013.

SUBJECT: Authorize an Agreement with North Central Texas Council of Government for Facilitation of Training for the North Texas Urban Shield Exercise

The North Central Texas Region is conducting a comprehensive multi-discipline, multi-jurisdictional full-scale exercise on Saturday, November 9, 2013 to Sunday, November 10, 2013, hosted by Dallas Independent School District at 1403 Corinth Street. The North Central Texas Council of Governments (NCTCOG) is sponsoring this exercise under the direction of the Emergency Preparedness Planning Council (EEPC), Regional Emergency Preparedness Advisory Council (REPAC), and regional working groups and has asked that the Police department facilitate training for this exercise.

The goal for this exercise is to increase proficiency levels in identified target capabilities and enhance regional response to large-scale incidents. This exercise is designed to assess the region's ability to successfully respond to and manage multiple terrorist events and other emergencies occurring simultaneously throughout the region. A variety of participating work groups such as Special Weapons and Tactics (SWAT), Explosive Ordinance Disposal (EOD), Urban Search and Rescue, Emergency Medical Services (EMS), Hazardous Materials Response and Fusion Centers from various agencies throughout the North Texas Region will participate.

The City is seeking recommendation from the Public Safety Committee to authorize an agreement with North Central Texas Council of Government for facilitation of training for the North Texas Urban Shield Exercise. This item is scheduled for the City Council Agenda on October 8, 2013.

SUBJECT: Authorize a Three-Year Master Agreement for Tactical Medical Supplies

Upon completion of a formal bid process, the City seeks authorization to initiate a three-year master agreement for tactical medical supplies totaling \$340,294 with the lowest responsive & responsible bidders, Tactical Medical Solutions in the amount of \$124,757 and Kentron Healthcare in the amount of \$215,735.

This three-year master agreement will provide for the purchase of tactical medical kits which include specialized tourniquets and bandages for the Dallas Police Department. Since 2004, specialized units of the Dallas Police Department have employed enhanced "tactical" first aid training and equipment designed to save lives of officers and citizens in the event of injury. Since the initial deployment, the lives of both officers and citizens have been saved by Dallas Police Officers with this equipment.

Based on technology and medical findings from US Armed Forces casualties, these kits are designed to stop bleeding and save lives in the critical time interval between when wounding occurs and when traditional emergency medical services can be accessed. In the event of a wound with severe blood loss, the most common preventable cause of death, even a matter of minutes can mean the difference between life and death. This department-wide deployment will allow us to provide our officers and our city with the most up to date, potentially life-saving equipment that is available.

The City is seeking a recommendation from the Public Safety Committee to authorize this master agreement for tactical medical supplies. This item will be placed on the City Council Agenda on September 25, 2013.

On September 6, 2013, at approximately 5:06 p.m., Dallas Officers received information from the police dispatcher that Garland Police Department was requesting assistance in locating and stopping an aggravated assault suspect. Officer #1 (Dallas Officer) responded and located Officer #2 (Garland Officer) and the suspect at the intersection of Highway 175 and Buckner Boulevard. Officers #1 and #2 initiated a felony traffic stop and ordered the suspect from the vehicle. When the suspect refused to comply, both officers approached the suspect's vehicle at which time a struggle ensued. During the struggle, the suspect was able to put the vehicle in gear and attempted to drive away with both officers hanging from the vehicle. As the struggle continued, the suspect reached into his waistband for what officers believed to be a weapon. Officers #1 and #2, fearing for their lives, fired their weapons at the suspect. After firing their weapons, the suspect was able to drive away. The suspect reentered the freeway where he collided with the median before driving off the freeway onto the service road where he struck a stop sign before the vehicle came to a stop. Additional officers and supervisors responded to the location and found the suspect still inside the vehicle. The suspect was transported to Baylor Medical Center by Dallas Fire and Rescue where he was pronounced deceased. No officers were injured during this incident.

The medical examiner has ruled that the cause of death was the result of a self-inflicted wound. A pistol was recovered inside the suspect's vehicle.

On June 26, 2013, at approximately 9:00 p.m., officers in full uniform and driving a marked police vehicle responded to a Theft in Progress call at 1921 Martin Luther King Jr. Boulevard. The comments on the call for service sheet stated that a security guard had the suspect at gun point and the suspect may be armed. When officers arrived at the location, the suspect and security guard were standing outside. The officers approached the suspect and instructed him to put his hand on the push bumper of their squad car. The suspect refused and began reaching in his pocket. Officer #1 drew his taser and began giving the suspect loud verbal commands to show his hands. The suspect refused to comply with Officer #1's commands and continued reaching into his pocket. Officer #1 then deployed a five second burst from his taser which knocked the suspect to the ground. The suspect pulled the prongs from his chest, drew a knife from his pocket and began running down Martin Luther King Jr. Boulevard. Officers #1 and #2 chased the suspect down the street at which time the suspect ran into a check cashing business located at 2310 Martin Luther King Jr. Boulevard. The business was occupied by a clerk that was working inside. The suspect at this time was holding onto the door in an attempt to keep Officers #1 and #2 from entering the business. Officer #1 gave loud verbal commands for the suspect to come out of the business and to drop the knife; however, the suspect refused to comply. Officer #1 attempted to pull the door open but the suspect kept pulling the door closed. All of a sudden the suspect opened the door and lunged at Officer #1 with the knife in a raised position. Fearing for his life, Officer #1 fired his weapon at the suspect. Seeing the suspect lunging toward Officer #1 with the knife, Officer #2 fired at the suspect as well. The suspect was struck and transported to Baylor Hospital by Dallas Fire and Rescue where he was listed in stable condition. No officers were injured.

On July 17, 2013, at approximately 2:00 p.m., officers in full police uniforms and driving a marked police vehicle, responded to a Burglary in Progress call from the police dispatcher at 1639 Conner Drive. When officers arrived at the location, they were met by the neighbor who stated he heard loud noises coming from the residence next door and he believed someone had broken in. The residence and the surrounding yard were completely dark. The officer drew their weapons and split up to search the residence in an attempt to determine if someone was inside and if so the point of entry. Officer #1 entered the unlit back yard, heard someone yelling loudly and observed the sliding glass door to the

residence open. Shining his flashlight into the residence, Officer #1 observed the suspect standing inside the residence yelling something unintelligible. Officer #1 began giving the suspect loud verbal commands to exit the residence, show his hands and to get on the ground. The suspect exited the residence, ran around in circles, got on his knees and curled into a semi ball continually yelling unintelligibly. Officer #1 then called out to Officer #2 informing Officer #2 that he had the suspect and for him to come to the backyard. Officer #2 also heard the suspect yelling unintelligibly as he walked down the side of the residence. Hearing Officer #1 calling for him, Officer #2 jumped the fence in order to provide cover for Officer #1. Officer #1 asked Officer #2 if he had the suspect covered. After assuring that Officer #2 had the suspect covered, Officer #1 holstered his weapon and drew his taser. The suspect then suddenly threw an object at Officer #1. The object bounced off Officer #1's head. The suspect then jumped up and charged directly at Officer #2 reaching toward the officer's weapon. Officer #2 was positioned with the fence to his back leaving him nowhere to retreat. Fearing for his safety, Officer #2 fired his weapon at the suspect. Seeing the suspect charging Officer #2, Officer #1 deployed his taser at the same time Officer #2 fired his weapon. The suspect was transported to Baylor Medical Center where he was listed in critical condition. No officers were injured as a result of this incident.

It was later determined that the object thrown by the suspect was a cellular phone. The prongs from the taser were located inside the suspect's clothing.

On May 22, 2012, at approximately 4:50 p.m., while working in an undercover capacity, Officer #1 was dropped off by Officer #2 in the Mountain Valley Apartment complex located at 5900 Stretch Drive to make a narcotics purchase from a suspect. Officer #1 walked to the apartment alone, entered, paid for the drugs and waited alone in the apartment while Suspect #1 went to retrieve the drugs. When Suspect #1 returned to the apartment, he informed Officer #1 that the drugs were not ready and that he would have to wait. Officer #1 at this time called Officer #2 to the location to purchase drugs also. Suspect #1 left the location a second time to see if the drugs were ready. While Suspect #1 was gone, Suspect #2 entered the apartment. When Suspect #2 entered the apartment, he immediately pulled a gun and became irate because Officers #1 and #2 were inside the apartment alone. Officer #1 attempted to explain to Suspect #2 that they were there to make a buy, but Suspect #2 kept making statements to the effect that he was not going back to jail and asking if they were the police. When Suspect #1 returned to the apartment, Suspect #2 began striking Suspect #1 in the head with a pistol. Suspect #2 then demanded

to see Officer #1's covert wallet at which time he began going through it. Suspect #2 then instructed Suspect #1 to get a pen and write down Officer #1's covert identification information. As Suspect #1 was writing Officer #1's information, Suspect #2 stated that he now knew where Officer #1 lived and that he would kill his family if he found out that he was a cop. Suspect #2 then demanded to see Officer #2's identification. Officer #2 pretended that he only spoke broken English and that he had no identification, only money. Officer #2 then produced \$500.00 at which time Suspect #2 stated, "He just bought y'all's way out of here." Officers #1 and #2 were then allowed to leave the apartment. Officers #1 and #2 made their way through the apartment complex to make contact with cover officers who were circling the complex. As Officers #1 and #2 neared their rendezvous location, they observed Suspect #2 coming out of Apartment #5961 with Witnesses #1 and #2. At this point, Officers #1 and #2 separated. Witness #1 entered the passenger side of the red vehicle as Witness #2 stood near the driver's side door of the vehicle. When Suspect #2 saw Officers #1 and #2, he began shouting something to the effect of, "I know you're the police." Suspect #2 first confronted Officer #1 and attempted to pull a handgun from his front waistband. As Suspect #2 was attempting to get the weapon, it appeared to Officer #1 that the sights on the weapon got caught in the waistband. Officer #1 then observed Suspect #2 charge in the direction of Officer #2 successfully drawing the handgun from the front waistband of his pants. Fearing for the life of Officer #2, Officer #1 fired several rounds from his duty weapon, striking Suspect #2. Officer #1 used a cellular phone to call for assistance from Dallas Fire and Rescue. Suspect #2 was transported to Methodist Central Hospital where he was pronounced deceased. No officers were injured.

Suspect #1 has been charged with two counts of Delivery of a Controlled Substance/Drug Free Zone, F/3. Witness #1 was transported to the Crimes Against Persons Division, interviewed and released. Witness #2 was transported to the Crimes Against Persons Division where it was discovered that he had sustained a minor injury to his right upper arm from the gunfire. Witness #2 refused medical treatment for the injury. Witness #2's injuries were photographed by the Physical Evidence Section and documented in an Injured Persons report. Witness #2 was also interviewed and released.

UPDATE: The Internal Affairs Division investigation revealed the officer was justified in his use of deadly force.

On June 2, 2012, at approximately 5:30 p.m., the Involved Officer was working a one man element in full police uniform and driving a marked police vehicle. While on routine patrol, the Officer observed the suspect commit a traffic violation when he

failed to use his turn signal prior to making a right turn into the Spring Ridge Apartment complex in the 3600 block of Folklore Trail. At this point, the Officer activated the overhead emergency lights and performed a traffic stop. The suspect, who was the driver of the vehicle, pulled the vehicle into a parking spot. As the Officer approached the vehicle, he could smell the odor of marijuana emanating from the driver's window. The Officer asked the suspect if there were any drugs or weapons in the vehicle, to which the suspect responded that there were not. The Officer noticed that the suspect was acting nervous, so he instructed the suspect to exit the vehicle. When the suspect exited the vehicle, the Officer turned the suspect away from him in order to perform a Terry Frisk of the suspect's person. While conducting the pat down search, the Officer observed the butt of a gun protruding from the suspect's right side waistband. The Officer immediately grabbed the suspect's hands and yelled, "Don't grab the gun!" The suspect then began to struggle with the Officer attempting to pull his hands away. During the struggle, the suspect was able to free his right hand and reach for the gun he had in the waistband of his pants. Fearing for his life, the Officer fired one round from his duty weapon, striking the suspect. The suspect was transported to Methodist Central Hospital by Dallas Fire Rescue where he was pronounced deceased. The officer was not injured.

There were two additional occupants in the suspect's vehicle who were transported to the Crimes Against Persons Division, interviewed and released. Recovered at the scene was a fully loaded 40 caliber Springfield Arms handgun that had been reported stolen out of Plano, Texas.

UPDATE: The Internal Affairs Division investigation revealed the officer was justified in his use of deadly force.


On December 6, 2012, at approximately 3:45 p.m., officers in full police uniforms and driving a marked police vehicle responded to an Armed Encounter call from the police dispatcher at the intersection of Castlefield Drive and N. St. Augustine Road. The comments on the call stated that a black male was walking down the street carrying a gun in his hand. As the officers turned onto Castlefield Drive, they were met by a witness who informed them that the suspect was walking down the street. The officers continued down

Castlefield Drive at which time they observed the suspect walking toward them carrying a shotgun. Both officers exited their vehicle, drew their weapons and began giving the suspect loud verbal commands to stop and drop his weapon. The suspect ignored the officers' commands and continued walking in the direction of the officers. As the suspect walked toward the officers he stated, "Shoot me, shoot me." The officers continued giving loud verbal commands for the suspect to stop and drop his weapon. The suspect refused to obey the officers' commands while continually stating, "Shoot me, shoot me." At that point, the suspect began to raise the shotgun in the direction of Officer #1. Fearing for his life, Officer #1 fired his weapon at the suspect. Officer #2, also fearing for the safety of Officer #1, fired his duty weapon at the suspect. Dallas Fire and Rescue transported the suspect to Baylor Medical Center where he was pronounced deceased. No officers were injured during this encounter.

UPDATE: The Internal Affairs Division investigation revealed the officers were justified in their use of deadly force.
