## 3. Overview of Functions and Selection Process for Administrative Law Judges

Presenter: Patricia Marsolais, Director, Civil Service Department

The purpose of this presentation is to provide an Overview of the Functions and Selection Process for Administrative Law Judges.

 Biannually the City Council appoints three to five Administrative Law Judges to hear demotion or discharge appeals for eligible City employees. The authority for these appointments is derived from City Charter, Chapter XVI, Section 12.1. This is the final level of administrative appeal for an employee. Pursuant to Section 34-40 of the Dallas Personnel Rules an employee has the option of having the appeal heard by a three person panel called a Trial Board (TB) or an Administrative Law Judge (AJ).
