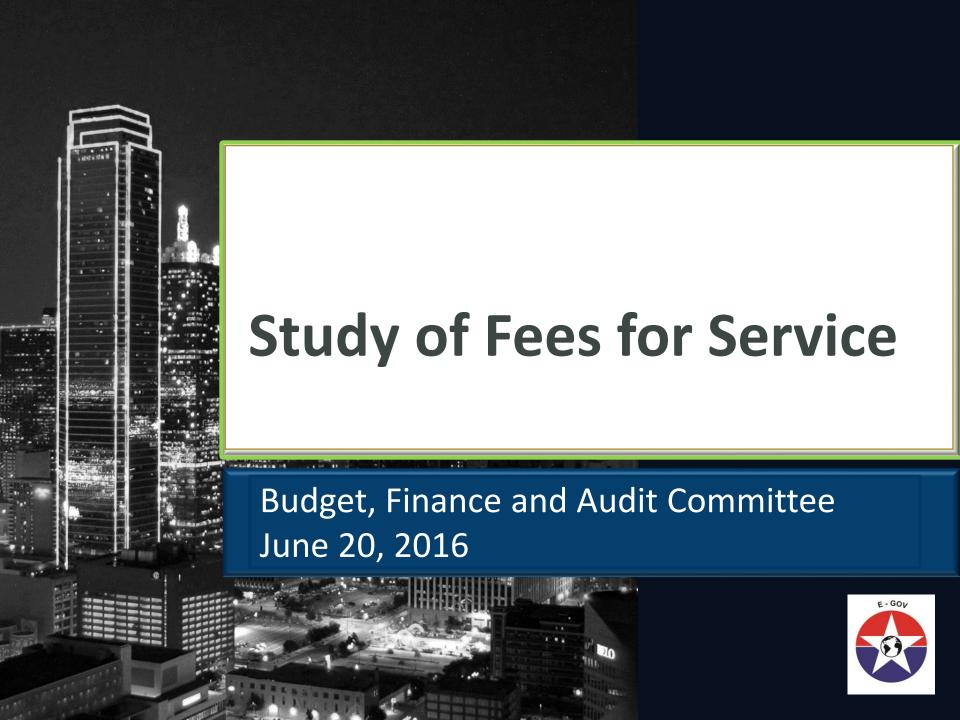

- Provide overview of annual fee study conducted by MGT of America, Inc.
- Review proposed fee adjustments for FY 2016-17
- Review cost recovery levels of current fees set at less than 100% cost recovery

Background

- The City's Financial Management Performance Criteria (FMPC) #15 requires:
 - An annual review of selected fees and charges to be conducted to determine the extent to which the full cost of associated services is being recovered
 - Fees and charges to be reviewed at least once every four years
- City contracted with MGT of America, Inc. for fee/cost recovery study
 - FY 2015-16 is MGT's 4th year as City's consultant

FY 2015-16 Fee Study

- Current fee study includes following departments:
 - Library 66 fees
 - Sanitation 10 fees
 - Sustainable Development 61 fees
- *Code Compliance is conducting a separate fee study to analyze new Single-Family Rental Properties Program
- Study is comprised of hourly rates of staff providing service and time spent to provide service
- Total cost is recognized as sum of direct cost together with a proportionated share of allowable indirect costs
- MGT calculated cost of providing each service, both on per-unit and total annual basis

FY 2015-16 Fee Study

- Consultant's focus is on cost and time allocation
- Staff recommendations also consider:
 - Market comparisons
 - Incenting behavior
 - Price elasticity
 - Council priorities
 - Magnitude of increase

FY 2015-16 Fee Study – <u>Library</u>

- Cost centers and programs included in FY 2015-16 fee study:
 - Circulation
 - Central Library room rentals
 - Branch Library room rentals
- Combined cost recovery level for Library fees is 85%
- No proposed fee adjustment
 - Circulation fees are set at a rate to encourage use of libraries
 - Room rental fees are market priced and not driven by cost (Library staff have determined that rates are competitively set as is and encourage use)

FY 2015-16 Fee Study – Sanitation

- Cost centers and programs included in FY 2015-16 fee study:
 - Residential
 - Commercial
 - Animal pick up fees
- Combined cost recovery level for studied fees is 97%
 - Full cost recovery once extra cart and recycling revenues are included
- Sanitation Department's proposed fees are determined using an internal fee/revenue methodology that is reviewed by City Auditor's Office annually
- Consultant's fee study serves as an additional independent review to ensure that City is not over-recovering on Sanitation's fees

FY 2015-16 Fee Study – Sanitation

- Current projections will require \$1.53 per month increase in sanitation fee from \$22.79 to \$24.32 per month
 - Fee increase due primarily to:
 - Increase in day labor contract
 - Step-up in franchise fee from 1% to 2% for street/alley maintenance
 - Decline in revenues from sale of recyclables (commodity price reductions)
 - Other expenses such as fleet, fuel, IT, pension, etc. have not yet been factored into cost of service
- Gate rate at McCommas Bluff landfill is still under review for adjustment

FY 2015-16 Fee Study – <u>Sustainable</u> Development and Construction Services

- Cost centers and programs included in FY 2015-16 fee study:
 - Engineering (Enterprise Fund)
 - Zoning (Enterprise Fund)
 - Historic Preservation (General Fund)
- Combined cost recovery level for engineering and zoning fees is 51%
 - Fees set to remain competitive with area cities on pre-development applications
- Combined cost recovery level for historic preservation fees is 0%
 - Fees set to reflect council priorities to encourage preservation
- Proposed fee adjustments will increase enterprise fund revenue by \$90K

FY 2015-16 Fee Study – Summary

- Library no revenue impact
- Sanitation no revenue impact to General Fund
- ■Sustainable Development no revenue impact to General Fund



Cost Recovery Levels

- As mentioned, departments consider several factors other than cost when setting fees such as:
 - Market analysis
 - Community-wide benefits vs individual benefits
 - Etc.
- Fees within following departments are currently set at less than 100% cost recovery based on most recent fee studies:
 - Library (discussed earlier)
 - Code Compliance
 - Parks and Recreation
 - Dallas Fire Rescue

Code Compliance Fees

- Fees set below cost recovery are primarily in Dallas Animal Services
 - Fees such as adoption and surgery fees are set below full cost recovery to encourage adoptions and spay/neuter services
- Other fees such as garage sale and group housing permit fees are set below full cost recovery to encourage participation and compliance

Parks and Recreation Fees

- Fees such as field rentals and pool admissions have historically been set at a rate less than full cost recovery in order to be competitive with neighboring cities and to encourage citizen participation
 - Proposal to increase field rental fees will be presented to Park Board later this year
 - Updated fee study will be included in new aquatics plan

Dallas Fire Rescue Fees

- Fees set below cost recovery are in Fire Inspection
 Division and Emergency Medical Services
 - DFR fees were studied in FY 2014-15 fee study cycle
- At that time, DFR determined current fee level by analyzing consultant's recommendations and comparing fees with other cities

Dallas Fire Rescue Fees

- Potential fee adjustments in DFR include:
 - Increase EMS transport fee to recover 100% of costs
 - Resident fee could increase \$93 from \$1,485 to \$1,578 (full cost) and potentially increase revenue by \$457K
 - Non-resident fee currently set at \$1,578 and will be reviewed further
 - Re-analyze inspection fees that have city subsidies of \$100K or more
 - Potential revenue increase of \$1.2M

SUBJECT Overview of Contract for Graphic Design Services

The City entered into a graphic design services contract in October 2014 to supplement the limited City resources in this area of expertise. The service contract gives the City access to specialized skill sets or resources while providing the flexibility necessary to produce quality work for multiple citywide initiatives simultaneously without assuming the fulltime personnel costs on an annual basis. The contract was utilized by a number of departments to purchase graphic design services to promote City programs and services. Some notable examples are attached as examples of the work directly produced by the contract in place today.

The agenda item to consider the replacement graphic design services contract was originally presented to Council for consideration on April 27, 2016 and deferred by City Council. Subsequently the item was deferred by the City Manager on May 11, 2016 and by the City Council on May 25, 2016.

Agenda item 44 on your June 22nd Council agenda is a recommendation to enter into a three-year service contract for graphic design services with El Creative, Inc., most advantageous proposer of ten – Not to exceed \$550,106.

As with all service contracts with the City, all departments have access to utilize the services and the purpose of the service contract is to establish firm pricing for services that are ordered on an as needed basis. There is not a guarantee of the amount the City will utilize during the contract period.

The City sent out 1,715 notices to the vending community to encourage competition resulting in ten proposals being received. The proposals were reviewed and evaluated by a seven member evaluation committee with the resulting summary scoring deeming El Creative, Inc. the most advantageous proposer. El Creative, Inc. is a certified minority owned firm and plan's to utilize two M/WBE firms to work on the City contract representing 25% planned participation exceeding the City's aspirational goal of 23.8% participation for service contracts.

In addition to the work El Creative, Inc. has produced under their current service contract, they have produced work for the Dallas Love Field Modernization Program to include the LOVE EVOLUTION concept at the airport. Other notable references include work for Wing Stop, Home Depot, American Red Cross and the Dallas Film Society.

Overview of FMPC

- > Financial Management Performance Criteria (FMPC) are a set of standards which guide City's financial decisions
- > Originally adopted in 1978
- > Criteria are grouped into categories:
 - Operating programs
 - Capital & debt management
 - Accounting, audit, & financial planning
 - Cash management
 - Grants & trusts
- Dallas Water Utilities has its own set of criteria that govern its system

FMPC Review/Revisions

- > FMPC monitored for compliance at multiple intervals during each fiscal year including:
 - During budget process
 - At fiscal year-end
 - Prior to each debt issuance
- > FMPC has been amended periodically by Council:
 - Most recent revision approved October 2014
 - > Increased minimum unassigned fund balance of General Fund from 5% (18.3 days) to 8.2% (30 days)
 - Revisions were also made in 2011, 2008, 2007 and 2005

Capital & Debt FMPC

- Criteria related to capital and debt pertain to City's general obligation program including:
 - Prescribes debt limits
 - Outlines usage of certificates of obligation
 - Governs use of tax increment financing (TIF) and public improvement districts (PID)
 - Sets policy prohibiting use of debt to finance current operating expenses
- Dallas Water Utilities has its own set of capital and debt criteria

FMPC Criteria #17

- Criteria #17 governs amount of general obligation (GO) debt City can have outstanding
 - Cannot exceed 4% of market value of taxable property
 - Currently at 1.5% of market value of taxable property
- > Consider changing criteria from market value to taxable value
 - Texas Government Code uses taxable value as debt limit as do Dallas' peer cities
- Additional consideration of lowering 4% threshold in FMPC #17 to lesser amount
 - And/or establish additional criteria to phase down percent of total tax rate used for debt service

FMPC Criteria #17

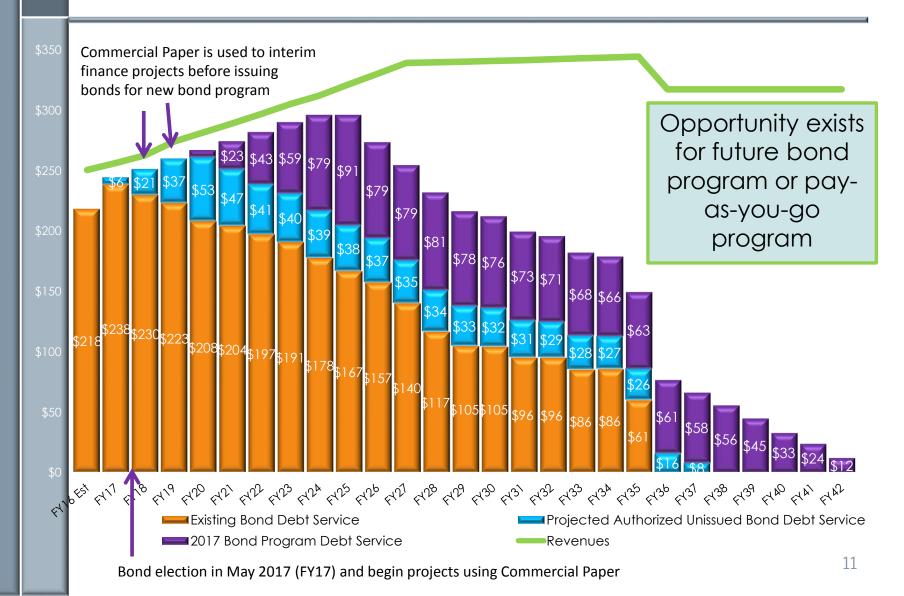

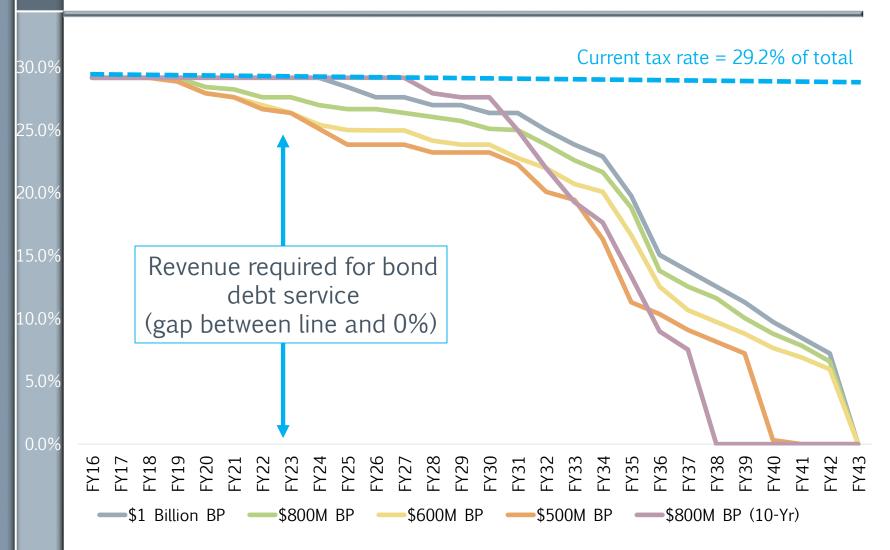

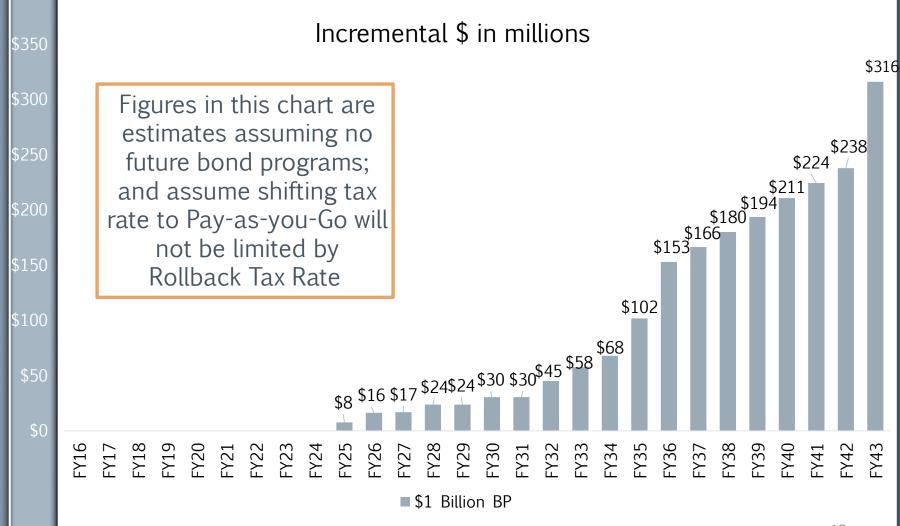
Projected Future Debt Service (\$ in millions)

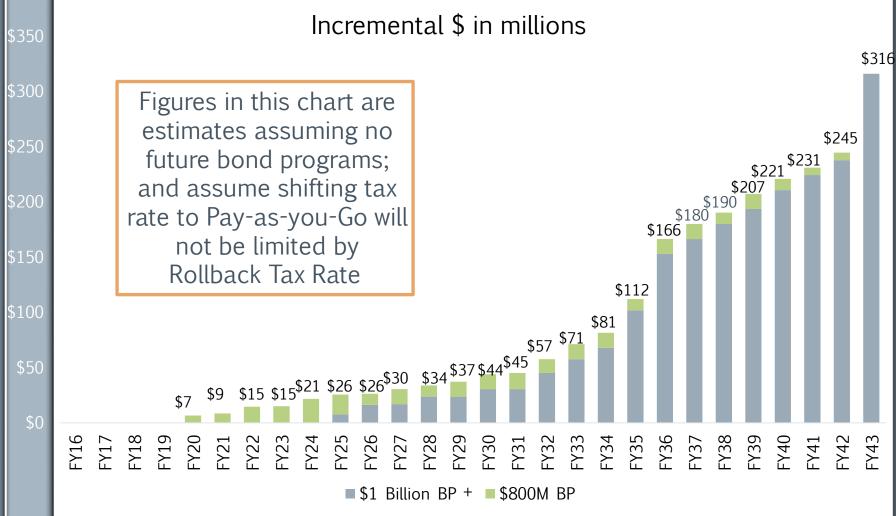


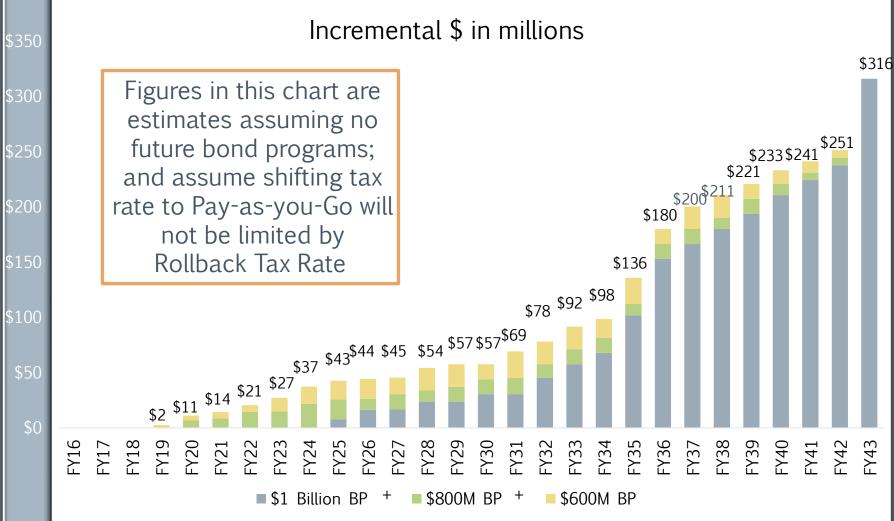
Debt Service as % of Tax Rate

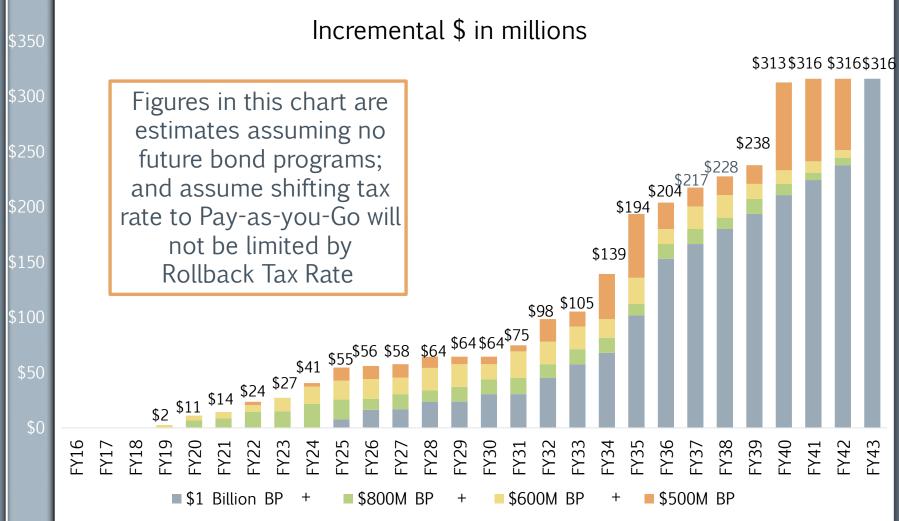

Pros/Cons of Pay-as-you-Go Program

- > Pros of pay-as-you-go program
 - Reduces City's long-term debt
 - Reduces expense by eliminating future interest cost
 - Eliminates potential for interest rate exposure
 - Does not require rating agencies
- > Cons of pay-as-you-go program
 - Shifting tax rate from debt service to pay-as-you-go is subject to rollback tax rate limitations
 - Four prepared scenarios show ~\$100m cash in a given year is not available until FY32 or later
 - > City typically awards \$100m to \$150m annually on capital projects
 - Condition of City infrastructure will worsen during period between 2017 bond program and time that sufficient cash is accumulated in pay-as-you-go program
 - > Street degradation averages between 4.2%-4.8% annually; 10-year wind up period could have devastating effect on street conditions
 - Funds for pay-as-you-go could be redirected for other purposes by future City Councils

Revisions to FMPC #17

- > Criteria #17 could be revised to reflect a debt limit based on taxable values rather than market value
- Criteria #17 could be revised and change threshold limit from 4% of market value of property to a lesser amount such as 2% of taxable value
 - Or phase reduction to a lesser amount over time
- Additional criteria could be added to establish policy to reduce percent of tax rate allocated to debt service from current 29.2%

PURPOSE

Address Council questions on the use of bond funds and savings for new projects:

- Switching projects
- Use of savings
- Discretionary funds

CHARACTERISTICS OF BOND PROPOSITIONS

- Each bond program (BP) is divided into individual propositions
- Voters approve propositions separately
- Only like projects can be in a proposition
 - Ex. Streets cannot be grouped with parks, and libraries with fire stations
- Funds from one proposition cannot be used to fund projects in a different proposition, unless language in a proposition is broad enough to incorporate the change

CHARACTERISTICS OF BOND PROPOSITIONS - CONT.

Propositions are usually written as a general description of the work and type of projects to be done but can be a specific lists of projects

Example of General Language

2012 BP - Proposition No. 1 - Streets and Transportation

Shall the city council of the city of Dallas. Texas, be authorized to issue general obligation bonds of the city in the aggregate principal amount of \$260,625,000 for the purpose or purposes of providing funds for permanent public improvements, to-wit: planning, designing. constructing, reconstructing, improving, extending, and expanding streets, thoroughfares, freeways, alleys, sidewalks, bridges, and pedestrian and bike ways, including related storm drainage facilities and improvements. signalization. signage, video roadside cameras, and other traffic and signal controls, street lighting, landscape. streetscape and median improvements, and the acquisition of land therefore

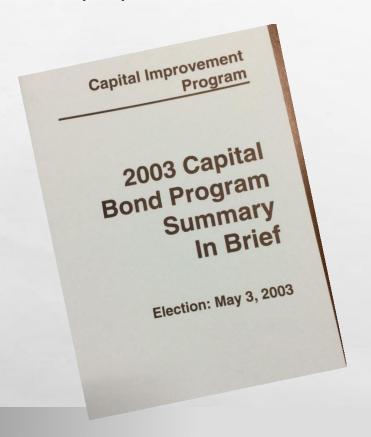

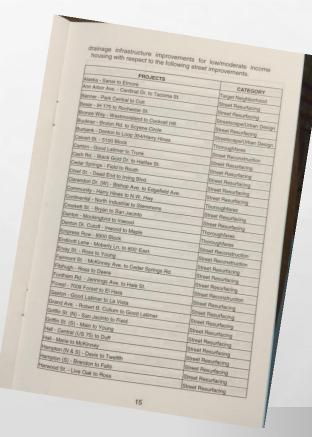
2003 BP- Proposition 10 - Specified Street Projects

Shall the city council of the city of Dallas, Texas, be authorized to issue general obligation bonds of the city in the aggregate principal amount of \$67,900,000 for the purpose of providing funds for permanent public improvements, to-wit: planning, designing, constructing, reconstructing, improving, extending, and expanding the streets, thoroughfares and freeways specified on Attachment 1 to this Election ordinance including sidewalks, storm drainage facilities and improvements, signalization, signage, and other traffic and signal controls, street lighting, streetscape and median improvements in connection therewith, and the acquisition of land therefor

COMMITMENT TO VOTERS

Although the propositions are written generally, the City produces a list of the specific projects to be done under each proposition





COMMITMENT TO VOTERS CONTINUED

- Most of the projects in these lists are specific
 - Ex. Street from here to there to be resurfaced
- Some projects are unspecified-
 - Ex. 50/50 Sidewalks and traffic signals
 - Allows for response from the public or needs as they arise
- Lists are widely distributed to the public during the election campaign
- These lists reflect the city's commitment to voters

SWITCHING PROJECTS

General language allows projects to switch out and add new ones; however, to fulfill the City's commitment to voters, projects are only changed out under limited conditions (rarely occurs):

- · Project was done by another agency or through a different funding method
- Public no longer wants the petition project or developer backs out
- Public consensus on the final design of the project cannot be reached
- Environmental permits cannot be obtained
- Insufficient funding
- Council changing priorities

Staff works with the council member on the switch

Full council votes on the change when the original project's funding is used for a new project resulting from a switch

USE OF SAVINGS - IN GENERAL

- Schedules for projects are set after BP passage
- Typically, BPs last 3-5 years (however, some projects may be awarded after that period)
- To account for inflation, all projects are inflated to the midpoint
- Calculated savings from the earlier constructed projects pays for the anticipated higher cost of later projects
- If savings are used for new projects before all original projects are complete,
 there could be a funding shortage for some original projects
- If savings are still available after all bond program projects are done, the funding can be used for new projects or for paying debt service
 - Ex.- In the library proposition, after all projects were done, savings were used to design, renovate and/or build additional libraries

Appendix A is a sample summary of bond savings usage for multiple propositions/bond programs

THE MECHANICS OF USING SAVINGS

- When savings occur in a project, funds are moved to a contingency fund for later use or can be transferred directly to another project
- When the need for additional funding for a bond program project is known, departments inform OFS, for processing of fund transfers
- Changes are included in the annual capital budget for approval by Council
- Departments track both savings and anticipated extra funds needed for projects to make sure that these stay equivalent

USE OF SAVINGS - IN EXCEPTIONAL CASES

- Emergencies and unexpected conditions arise occasionally for which funding is needed (Ex. The damage to Jack Evans building after the shooting incident)
- Funding for these needed improvements can come from multiple sourcescontingency, operating funds, or the use of bond savings
- The department with the need for project funding works with OFS to determine the recommended funding source

DISCRETIONARY FUNDS

Propositions may set aside funds for projects not yet identified at the time of the bond election, called "Discretionary" amounts or projects

Examples:

'03 BP had funds for discretionary use by Council members for either street or park projects

- The decision as to whether the funding was for streets or parks was made when the bond election was called and so funding could not be switched from one proposition to the other after that time
- Some council members identified the use of these funds when the BP was called while others did not

Note: the City was criticized for using discretionary funds in this case

'12 BP did not fully list the housing and economic development projects to receive funding

Allows response to development opportunities as they arise

FUTURE POLICY DECISIONS

For the next bond program, Council has policy choices related to:

- Use of discretionary funding
- Whether propositions will be general or have specific project lists

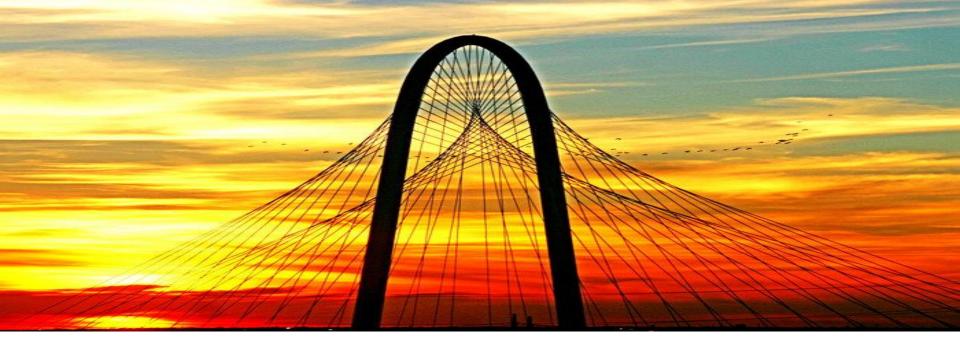

Sunset Review

- Sunset Review began in 2015 as an additional tool to be used by City staff to improve operations/efficiencies and reduce costs
- Through multiple tools including Sunset Review, staff have included savings and cost reductions in annual operating budgets
 - FY15 \$16.3m
 - FY16 \$15.7m
 - FY17 \$5.6m as of June 8th; with goal of at least \$12.5m



Sunset Review

- At request of council members and direction of City Manager, beginning with development of FY16 budget, additional analysis of departmental budgets was implemented
- Five year rotation schedule was put in place to conduct "sunset" and performance budget review of each department and service:

Line item expense budget	Fees and revenues
Staffing requirements to deliver service	Technology needs and opportunities
Contracts for services	Best practices
Performance measures	Benchmarking against others
Outsource opportunities	



Sunset Review

- Sunset Review is for purpose of conducting additional analysis of departmental budgets
 - To take a "deep dive" into department budget and operations
 - To identify opportunities to improve operational efficiency and effectiveness
 - To identify opportunities to have a positive budget impact through expense reductions or revenue increases
 - To eliminate outdated programs where possible
- Potential opportunities identified during Sunset Review process are further analyzed and implemented as possible over multiple years



Self-Evaluation Report

- Sunset Review process begins with each department conducting a complete, accurate, and thoughtful departmental self-evaluation including:
 - 1) Purpose and activities
 - 2) Source of funds and revenues
 - 3) Expenditures
 - 4) Personnel
 - 5) Performance
 - 6) Stakeholders
 - 7) Technology and equipment
 - 8) Other
- Department self-evaluation is more than compiling information for review teams to consider
- Self-evaluation is intended to be time/process for departments to consider their operations and activities (process is consistent with Business Plan initiative)



Considerations by Review Team

- Based on components presented to Council and criteria used in State of Texas process, following are <u>example</u> areas that teams consider:
 - 1) What is purpose of department?
 - 2) How does department contribute to achieving mission and goals of City?
 - 3) How does department meet legal requirements and/or mandates?
 - 4) What are appropriate measures of success for department?
 - 5) Is department effective and meeting performance measures?
 - 6) Are there opportunities to improve performance?
 - 7) Are there opportunities to streamline or improve efficiencies?
 - 8) Is department responsive to customer needs?
 - 9) Are all services, activities and line item expenditures needed?
 - 10) Are all staff/positions needed?
 - 11) What is appropriate span of control?



Process

Departments complete Self Evaluation Report Team reviews departmental report, makes observations, and identifies potential opportunities Potential opportunities are vetted by City Manager's Office and presented to City Council committee

Based on Committee and Manager feedback, opportunities are further analyzed for possible inclusion in upcoming annual budget

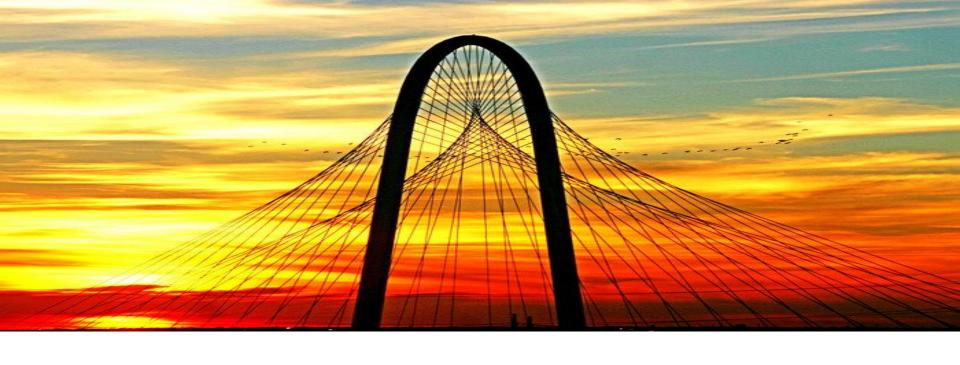
Summary of Year 1 Departments

- Example of savings realized from opportunities identified through Sunset Review process
 - Municipal Courts, City Attorney, & Judiciary reduce staffing and number of fully-operational court rooms due to decrease in number of citations – \$1.4m
 - Code Compliance adjusted vacancy rate to reflect delays in hiring - \$506K
 - Municipal Courts adjustment to "right size" staffing levels based on Court activity - \$253K
 - Police reduce civilian positions in Police Personnel Services
 Division \$160K
 - Code Compliance consider transferring Transportation Regulation from Code to Aviation in FY17 - \$578K

- 9. Vehicle Towing & Storage revenues are projected to be \$447 above budget due to an increase in tows as well as vehicles staying on the auto pound property longer than anticipated.
- 10. Public Library revenue is projected to be \$96 below budget due to implementation of automatic renewal on materials that have been checked out at library locations and an increase in the usage of e-materials. Fines and late fees are not collected on e-materials as they are electronically recalled on the due date.
- 11. Vital Statistics revenues are projected to be \$133 above budget due to an increase in the sale of birth certificates.
- 12. Other Charges for Service revenue is projected to be \$1,953 below budget primarily as a result of contracting with fewer hospitals than anticipated for the Mobile Community Healthcare Program, a reduction in Fire Watch fees, and a reduction in the number of fire inspectors used at American Airline Center events.
- 13. City Secretary's Office is projected to be \$11 above budget due to higher than budgeted salary expenses.

- 14. Civil Service is projected to be \$6 above budget primarily due to salary expenses.
- 15. Court Services is projected to be \$410 below budget due to vacancies.
- 16. Elections is projected to be \$12 above budget due to the purchase of unbudgeted petition verification software.
- 17. Housing and Community Services is projected to be \$326 above budget due to several unbudgeted expenses including temp help, replacement of fire and alarm system at the MLK Community Center, items related to the master plan for the MLK and WDMP Community Centers, and various special events.
- 18. Judiciary is projected to be \$171 below budget due to vacancies.
- 19. Mayor and Council is projected to be \$101 above budget due to double filled positions and the unbudgeted use of temp help.
- 20. Non-Departmental is projected to be \$128 above budget primarily due to unbudgeted costs such as the actuarial review related to the Police and Fire Pension Fund and efforts related to ADA Compliance.
- 21. Office of Cultural Affairs is projected to be \$79 above budget primarily due to increased usage of custodial and security services based on events at the Majestic, Meyerson, and City Performance Hall facilities. These expenses are offset by corresponding revenue.
- 22. Park and Recreation is projected to be \$292 above budget primarily due to repairs related to flooding in 2015 and increased demand for contract classes.
- 23. Planning and Urban Design is projected to be \$238 below budget due to vacancies.
- 24. Police is projected to be \$2,243 above budget due to the anticipated purchase of additional squad cars using General Fund surplus.
- 25. Street Services is projected to be \$773 above budget primarily due to equipment maintenance costs.
- 26. Sustainable Development and Construction is projected to be \$300 below budget due to vacancies.
- 27. Convention and Event Services expenses are projected to be \$8,791 above budget due to increased food and beverage service based on event demand as well as an increased transfer to capital construction resulting from additional revenues. This action does not encumber funds; the purpose of a service contract is to establish firm pricing for services, for a specific term, which are ordered on an as needed basis.

This service contract will provide volunteer coordination services that will supplement and support various City departments in general duties and special events. Volunteer services include training for City staff and volunteers, coordination of the program, advertisement, background checks and the recruitment and placement of volunteers. The function of the volunteer coordinator is to manage and maintain the program by placing the best qualified volunteers with the requesting department or event. The contract will provide for all volunteers to have background checks.

VolunteerNow in collaboration with the Human Resources Department, will manage the volunteer coordination program to support the City and provide opportunities for citizens to become involved in City operations.

The City has historically utilized an average of 7,417 volunteers per year, resulting in approximately 347,500 service hours.

BACKGROUND (Continued)

The scope of service covers four key areas for volunteer coordination as well as tracking and reporting of volunteers:

- Advertisement of City volunteer opportunities
- Access to the VolunteerNow's criminal background check service
- Training opportunities and City volunteer coordinator support
- Community involvement and City communication

This program will also give residents an opportunity to learn how City services work and make meaningful contribution to the City's departments. This program will not replace existing employees, but provide an increase in the level of service the City is able to provide the residents of Dallas.

These volunteers support City departments and special events, such as the Mayor's Back-to-School Fair at which several hundred volunteers help distribute much needed school supplies.

Authorize the purchase of (1) twenty three pieces of fleet vehicles and equipment - Hudson Bus Sales, LLC in the amount of \$2,665,662 and Metro Fire Apparatus Specialists, Inc. in the amount of \$7,053,525, through the Houston-Galveston Area Council of Governments; (2) one pumper truck - Brasada Ford, Ltd. in the amount of \$151,750 through the Texas Multiple Award Schedule; and (3) one excavator with mower attachment - Landmark Equipment, Inc. in the amount of \$107,399 through the Texas Association of School Boards - Total not to exceed \$9,978,336 - Financing: Municipal Lease Agreement Funds (\$9,321,400), Aviation Current Funds (\$549,537) and Stormwater Drainage Management Current Funds (\$107,399)

BACKGROUND

This item will authorize the purchase of twenty five fleet vehicles and equipment for various City departments to include:

- ambulances 14
- pumpers 6 (5 fire pumpers, 1 type 6 wildland pumper)
- mass casualty incident apparatus 1
- aerial trucks 3
- excavator with mower attachment 1

These replacement apparatus will be used for actual response of various divisions of Fire-Rescue (DFR) in performing the duties of life safety for the residents of Dallas. Units will be utilized in emergency response to fire, medical and all other emergency situations.

BACKGROUND (Continued)

DFR responded to 230,755 emergency calls in fiscal year 2014-15. For these incidents, the number of DFR emergency vehicles dispatched totaled 337,830 accumulating approximately 1,137,100 miles in the City and is on pace to match and possibly exceed that mileage this fiscal year. Emergency services are vital to the City's community and therefore the equipment used in the delivery of these services must be effective and reliable.

The fire equipment being replaced (two aerial trucks, five fire pumpers and one type 6 fast attack pumper) has met its useful life of twelve to fifteen years. These vehicles have been evaluated using an established criterion to ensure that only vehicles that have exceeded their regular maintenance program are replaced. The equipment evaluation process uses criterion that includes life-to-date maintenance costs, recommended replacement mileage, recommended replacement life and a point system that includes down time, and number of work orders to determine vehicles productivity.

These vehicles being replaced have all been deemed too costly to maintain in the city's fleet and will be sold through a public auction process upon delivery of the replacement units.

A mass casualty incident (MCI) is any incident in which medical service resources are overwhelmed by the number and severity of casualties. Incidents such as aircraft crashes, passenger train and bus collisions, building collapse or any other emergency involving numerous people all can be a MCI event. This apparatus will provide large quantities of emergency medical equipment and supplies to any type of MCI event anywhere in the City. The apparatus will be housed at Fire Station 42, on the southern end of Dallas Love Field. This will provide immediate response to the airport and be centrally located to ensure timely response to other areas of the City.

This initiative is a result of Aviation and DFR identifying a much needed resource and collectively collaborating to arrive at the best possible solution. Aviation will provide funding for the apparatus, equipment and supplies while DFR will house, operate, re-supply and maintain the apparatus.

The purchase of one diesel powered, nine-ton, EPA Tier 4 certified, excavator and mower attachment will add to Trinity Watershed Management's (TWM) fleet of grounds maintenance equipment. This equipment will be used for vegetation management near river and creek banks, channels and floodways.

BACKGROUND (Continued)

The Texas Association of School Boards (Buyboard), Houston-Galveston Area Council of Governments (HGAC) and the Texas Multiple Award Schedule (TXMAS) conforms to the requirements of Texas Statutes that are applicable for competitive bids and proposals, in accordance with the Interlocal Cooperation Act, Chapter 791, Texas Government Code. In addition, Buyboard, HGAC and TXMAS receive bids from manufacturers and dealers throughout the United States.

PRIOR ACTION/REVIEW (COUNCIL, BOARDS, COMMISSIONS)

On January 11, 2012, City Council authorized a one-year master agreement for the purchase of one hundred ninety-six pieces of fleet equipment; and a one-year master agreement for the purchase of one hundred three pieces of fleet equipment by Resolution No. 12-0162.

BACKGROUND

This action does not encumber funds; the purpose of a master agreement is to establish firm pricing for goods, for a specific term, which are ordered on an as needed basis.

This agreement will provide National Sanitary Foundation 60 certified liquid carbon dioxide for water treatment at the Bachman and Elm Fork Water Treatment Plants. Liquid carbon dioxide is necessary for controlling the pH level and maintaining required alkalinity in Dallas' drinking water as required by the Environmental Protection Agency and Texas Commission of Environmental Quality.

Additionally, this agreement will provide liquid carbon dioxide tank rental and maintenance for the Bachman Water Treatment Plant and the maintenance of two city-owned tanks at the Elm Fork Water Treatment Plant. Rental of the tank ensures compatibility between tank and delivery truck connection types and thereby supports expedient service delivery; preventative maintenance will occur monthly and will include an annual inspection.

Water Utilities provides service to an estimated 2 million people in Dallas and surrounding communities.

This solicitation was structured in a manner which required bidders to submit a response using unit pricing. This bid resulted in a 4% decrease on comparable unit prices for the bid awarded in 2012.

BACKGROUND (Continued)

As part of the solicitation process and in an effort to increase competition, Business Development and Procurement Services (BDPS) used its procurement system to send out 1,024 email bid notifications to vendors registered under respective commodities. To further increase competition, BDPS uses historical solicitation information, the internet, and vendor contact information obtained from user departments to contact additional vendors by phone. Additionally, in an effort to secure more bids, notifications were sent by the BDPS' Resource LINK Team (RLT) to 25 chambers of commerce, the DFW Minority Business Council and the Women's Business Council – Southwest, to ensure maximum vendor outreach.

BACKGROUND

This item will authorize the acceptance and execution of the Veterans Treatment Court Grant from the Texas Veterans Commission's Fund for Veterans' Assistance. The Commission awarded the City a one-year grant with the project period from July 1, 2016 to June 30, 2017. The Veterans Treatment Court (VTC) seeks to identify veterans with chemical dependency who have at least one unadjudicated City of Dallas criminal citation. Eligible veterans will be offered an opportunity to participate in the VTC program where their criminal citations will be adjudicated and they will be assessed and assigned a case manager and referred to services such as alcohol/drug treatment and recovery support services. The VTC docket will be held at the South Oak Cliff Community Court, which is located inside the Dallas Area Rapid Transit Police Headquarters at 2111 South Corinth Street.

The Texas Veterans Commission has awarded the City \$300,000.00 in support of the VTC program for the first year. This includes the funding of two new full-time positions (Coordinator I and Manager I).

FISCAL INFORMATION

\$300,000.00 - Texas Veterans Commission Grant Funds

WHEREAS, the City of Dallas seeks to add a Veterans Treatment Court docket at the South Oak Cliff Community Court that will incorporate alcohol/drug treatment, recovery support services, screening, assessment, case management, and program coordination specifically for veterans; and

WHEREAS, the Fund for Veterans Assistance of the Texas Veterans Commission has awarded the City a one-year grant with the project period from July 1, 2016 to June 30, 2017; and

WHEREAS, the Texas Veterans Commission's Fund for Veterans Assistance has made grant funds available during the 2015-16 fiscal year and partially during the 2016-17 fiscal year to offer veterans facing criminal charges for substance abuse and possession an opportunity to enter a substance abuse recovery program in lieu of jail time; and

WHEREAS, such grant funding was awarded to the City on May 18, 2016; and

WHEREAS, the grant funding would benefit the City in its endeavor to reduce crime and help affected veterans become drug free and self-sufficient; and

WHEREAS, the City finds it in the best interest of the City's residents that the grant funds be accepted for the 2015-16 fiscal year and partially during the 2016-17 fiscal year; and

WHEREAS, the City agrees that in the event of loss or misuse of the grant funds, the City will return the funds identified as ineligible to the Texas Veterans Commission; and

WHEREAS, the City designates the City Manager or his designee as the grantee's authorized official, who has the power to apply for, accept, reject, alter, or terminate the grant on behalf of the City; **Now, Therefore,**

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

Section 1. That the City Manager is hereby authorized to **(1)** accept the 2016-17 Veterans Treatment Court Grant (Grant No. VTC160381) from the Texas Veterans Commission for expansion of the South Oak Cliff Community Court to include the South Oak Cliff Veterans Treatment Court project for the period July 1, 2016 through June 30, 2017 in an amount not to exceed \$300,000.00; **(2)** approve creating two new full-time positions to execute the proposed project; and **(3)** execute the grant agreement.

Section 2. That the City Manager is hereby authorized to establish appropriations in the Veterans Treatment Court Expansion Project Grant Fund S302, Department ATT, Unit 1955, various Object Codes per the attached Schedule, in an amount not to exceed \$300,000.00.

Section 3. That the Chief Financial Officer is hereby authorized to deposit grant funds in an amount not to exceed \$300,000.00 into Fund S302, Department ATT, Unit 1955, and Revenue Source 6516.

Section 4. That the Chief Financial Officer is hereby authorized to disburse grant funds from Fund S302, Department ATT, Unit 1955, in accordance with the attached schedule, in an amount not to exceed \$300,000.00.

Section 5. That the City Manager is hereby authorized to create two new full-time positions:

- Coordinator I who will coordinate the efforts of the court, the social service and case management clinic, and the service providers to maximize effectiveness of court operations, sentences, and compliance monitoring.
- 2. Manager I who will manage the cases of the court as well as coordinating outreach efforts with the Coordinator to recruit and retain clients.

Section 6. That the City Manager is hereby authorized to reimburse the Texas Veterans Commission Fund for Veterans Assistance of any expenditure found ineligible. The City Manager shall notify the appropriate City Council Committee of expenditures identified as ineligible not later than 30 days after the reimbursement.

Section 7. That the City Manager shall keep the appropriate City Council Committee informed of all final Texas Veterans Commission Fund for Veterans Assistance monitoring reports not later than 30 days after the receipt of the report.

Section 8. That this resolution shall take effect immediately from and after its passage in accordance with the provisions of the Charter of the City of Dallas, and it is accordingly so resolved.
