Briefing on critical system vulnerabilities and authorize Supplemental Agreement No. 1 to increase the service contract with West Shore Services, Inc. for immediate security enhancements to address an imminent threat to public health and safety and to address a reasonably unforeseen situation - Not to exceed \$100,000, from \$567,368 to \$667,368 - Financing: Current Funds (subject to appropriations)

BACKGROUND

On April 8, 2017 at 11:42 p.m. an intrusion into the City's outdoor warning siren system unexpectedly activated and sounded sirens throughout the City. Staff attempted to silence the system through appropriate measures which were unsuccessful. The intrusion into the system continually sent alert messages to each of the individual sirens to continuously sound until the system was fully disconnected from operation.

It has been determined that a security vulnerability in the system was exploited causing complete loss of control over the system. Repeated messages sent by the intruder countered all efforts to silence the system except to completely deactivate the system.

This Supplemental Agreement increases the value of the contract by \$100,000 for immediate security enhancements to the outdoor warning siren system following the intrusion of the system on April 8, 2017.

This action does not encumber funds; the purpose of a service contract is to establish firm pricing for services, for a specific term, which are ordered on an as needed basis.

This will provide immediate security enhancements and repair services for the City's outdoor warning siren system that currently consists of 156 sirens strategically located throughout the City. The system alerts residents of approaching or existing hazardous conditions throughout the City to ensure the widest possible coverage. Typically, the outdoor warning siren system is used as a warning tool for a tornado or other dangerous weather conditions, it is one of the primary means of emergency warnings for Dallas residents and visitors for all types of hazards.

PRIOR ACTION/REVIEW (COUNCIL, BOARDS, COMMISSIONS)

On August 26, 2015, City Council authorized a six-year service contract, for preventive maintenance and repair services for the City's outdoor warning siren system by Resolution No. 15-1521.

On November 9, 2016, City Council authorized a six-year service contract, for preventive maintenance and repair services for the City's outdoor warning siren system by Resolution No. 16-1798.

FISCAL INFORMATION

WHEREAS, on April 8, 2017 an intrusion caused activation of the City's outdoor warning siren system; and

WHEREAS, immediate security enhancements are required to provide complete restoration and functionality of the City's outdoor warning siren system; and

WHEREAS, on August 26, 2015, City Council authorized a six-year service contract, for preventive maintenance and repair services for the City's outdoor warning siren system by Resolution No. 15-1521; and

WHEREAS, November 09, 2016, City Council authorized a six-year service contract, for preventive maintenance and repair services for the City's outdoor warning siren system by Resolution No. 16-1798.

Now, Therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

SECTION 1. The City Manager is hereby authorized to sign Supplemental Agreement No. 1 with West Shore Services, Inc. (VS0000052434), approved as to form by the City Attorney, for immediate security enhancements in an amount not to exceed \$100,000, increasing the service contract from \$567,368 to \$667,368. If the service was bid or proposed on an as needed, unit price basis for performance of specified tasks, payment to West Shore Services, Inc. shall be based only on the amount of the services directed to be performed by the City and properly performed by West Shore Services, Inc. under the contract.

SECTION 2. That the Chief Financial Officer is hereby authorized to disburse funds in an amount not to exceed \$100,000 (subject to appropriations) from Service Contract No. MASCMGTFY2017SIRENCT.

SECTION 3. That this resolution shall take effect immediately from and after its passage in accordance with the provisions of the Charter of the City of Dallas, and it is accordingly so resolved.
