SUBJECT Owner Occupied Housing Development Program Proposals

On January 13, 2016, the City Council approved the Owner Occupied Housing Development Program and allowed the issuance of a Notice of Funding Availability to solicit applications for the development of residential ownership opportunities within the city of Dallas.

The Notice of Funding Availability (NOFA) was issued on January 14, 2016 and the Department received 14 proposals from non-profit and for-profit developers. Projects were reviewed by a Loan Committee consisting of one private banker and City staff from Economic Development, Sustainable Development and Construction, and Housing/Community Services Departments.

Proposals were reviewed by the Committee members In accordance with the Program Criteria set forth by the Council. They were also underwritten using U.S. Department of Housing and Urban Development (HUD) standards. The Committee also interviewed each developer regarding their proposal.

The Committee also considered each project in accordance with the City's obligation to affirmatively further fair housing, and staff ensured that no project concentrated poverty or otherwise created a disparate impact by including a mix of income housing choices for projects in high-poverty census tracts.

With the Housing Committee agenda full, timing for agenda item submission, and the need to get contracts approved to allow developers to begin construction, the projects could not be individually briefed but are ready to be considered by full City Council on May 25, 2016.

Attached is a list of development projects being recommended. Additional details regarding timelines, terms, and type of funding will be addressed in the agenda items.
