SUBJECT **FY 2018-2019 Homeless Response System and Landlord Subsidized Leasing Updates**

Summary

Attached is briefing presentation on FY2018-2019 Homeless Response System and Landlord Subsidized Leasing Updates related to Request for Competitive Sealed Proposals (RFCSP) solicitations issued by the Office of Procurement Services (OPS) for Office of Homeless Solutions (OHS) funding.

Background

The Office of Homeless Solutions released two RFCSP's through OPS on January 31, 2019: Strengthening the Homeless Response System in the amount of \$1,446,588 and Landlord Subsidized Leasing Program in the amount of \$1,300,000. Strengthening the Homeless Response System includes unspent Emergency Solutions Grant (ESG) funding from previous fiscal year, FY18-19 budget enhancements in the amount of \$500,000, and reprogrammed OHS general fund dollars. The Landlord Subsidized Leasing Program includes FY18-19 budget enhancement. Proposals were due on March 14, 2019 and the evaluation committee has finalized their review and made recommendations to OHS on awards.

OHS supports the recommendations of the evaluation committee and recommends moving selected vendors forward for City Council consideration.

The Citizen Homelessness Commission was briefed on May 9, 2019.

Supportive Housing for Seniors Overview

- The goal of this program is to reduce the number of homeless seniors (ages 55 and over) by providing housing rental subsidies and supportive services for up to 24 months.
- This funding is expected to support individuals (ages 55 and over) who are prioritized as chronically homeless (P1 through P4) by the local Continuum of Care.

Catholic Charities of Dallas, Inc. proposed to serve 22 seniors by providing rental subsidies, utility assistance, and supportive services for a 12-month period.

Workforce Sustainability Overview

- This pilot program provides funding for an administrative entity to implement a certificate-earning, career-pathways workforce training program for persons experiencing homelessness.
- The goal of the program is for participants to positively exit the program with stable housing and full-time employment.
- The program is intended to support approaches that remove barriers to housing, education, training, and employment opportunities and retention and focus on specialized skills training and workforce opportunities in regional high demand industries.

Community Council of Greater Dallas proposed to serve 75 persons experiencing homelessness by providing certificate-earning, career-pathway workforce training and job placement in the healthcare industry.

Through a separate informal solicitation that took place in the Fall, another provider, Succeeding At Work, has been selected to provide job readiness training and employment skills development services for participants under the Workforce Sustainability Program. A contract for these services in the amount of \$38,401 is currently pending.

Landlord Subsidized Leasing (Track 3) Overview

- The program provides funding for a qualified entity to administer financial assistance for eligible homeless persons and risk mitigation funds for landlords, to address challenges faced by homeless persons as they navigate the rental market.
- Financial assistance (up to \$1,200,000) includes move-in and rental assistance for homeless individuals and families in need of temporary assistance (up to 24 months).
- Risk mitigation funds (up to \$100,000) covers holding fees, damage claims, and vacancy loss for participating landlords who reserve qualifying units for homeless individuals and families.

Performance Measures

Programs funded through OHS will include performance measures that support the department's overarching goals to:

- Decrease the total number of persons experiencing homelessness and the number of homeless encampments in the City of Dallas
- Increase the total number of emergency shelter beds and supportive housing units in the City of Dallas
- Increase the total number of unduplicated homeless persons placed into housing in the City of Dallas
- Increase the percentage of unduplicated homeless persons placed in housing in the City of Dallas who remain housed after six months.

OHS contractual performance measures require collaborative efforts of service providers and speak to the mission of combating homelessness.
