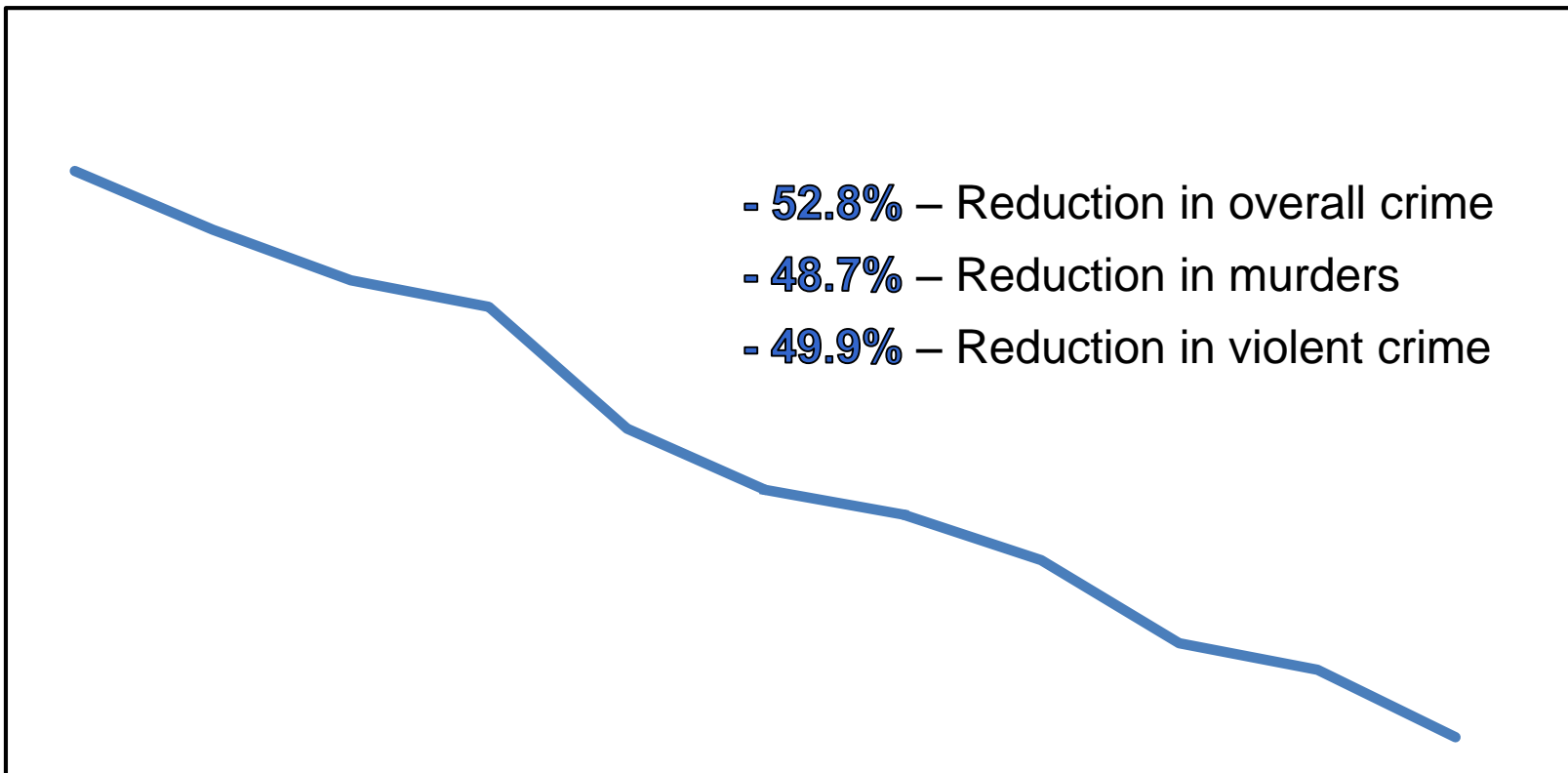

Significant Criminal Enforcement Activity

Narcotics and Vice (City-Wide)

July 15, 2015 - A joint task force led by the Federal Bureau of Investigation (FBI) and the Dallas Police Department resulted in several drug related arrests and distribution conspiracy charges for heroin, methamphetamine and cocaine in the Dallas-Fort Worth area.

- 46 federal indictments
- Identified airport employees transporting contraband
- 27 guns off the street
- 1,700 grams of cocaine
- 15 kilograms of methamphetamine
- \$400,000 cash seizure



Significant Criminal Enforcement Activity

METRO/CSU (District 11)

July 1, 2015 - METRO officers apprehended a murder suspect wanted for murdering a female and burning her body inside a vehicle. Officers received information from detectives regarding the suspect's location. METRO officers along with the North Central Patrol Division apprehended and arrested the suspect at 100 North Coit Road in Richardson.



Significant Criminal Enforcement Activity

Patrol (District 8)

July 7, 2015 - 6900 South Great Trinity Forest Way, a suspect pointed a black revolver at the complainant and took his vehicle. Officers arrived promptly to the scene, and through a coordinated effort, were able to locate the stolen vehicle. After a brief pursuit, a felony stop was performed and the suspect was taken into custody and charged with aggravated robbery and evading arrest.



Significant Criminal Enforcement Activity

Patrol (District 1)

August 3, 2015 - Deployment detectives arrived for duty and learned of an ongoing string of aggravated robbery/aggravated sexual assault offenses. Detectives contacted the Robbery and Sex Assaults Units and found four cell phones had been taken during the offenses. The Deployment Unit located and arrested two of the suspects driving the victim's stolen vehicle at 3500 Sunnyvale Street. The handguns used in the offenses were recovered along with most of the stolen property.



Significant Criminal Enforcement Activity

Patrol (District 1)

August 14, 2015 - A home invasion robbery occurred at 500 Cold Town Lane. Officers responded and discovered the victim had also been shot and was transported to a local hospital. Officers located the victim's vehicle and arrested three suspects. Weapons, ammunition, and currency taken in the robbery were recovered.

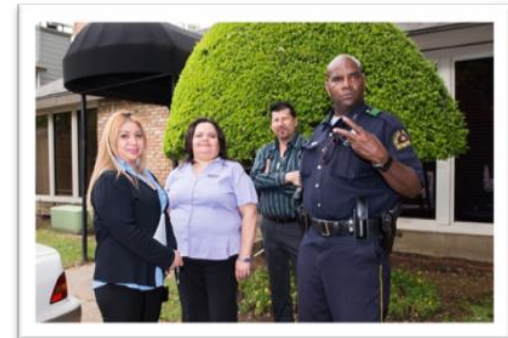

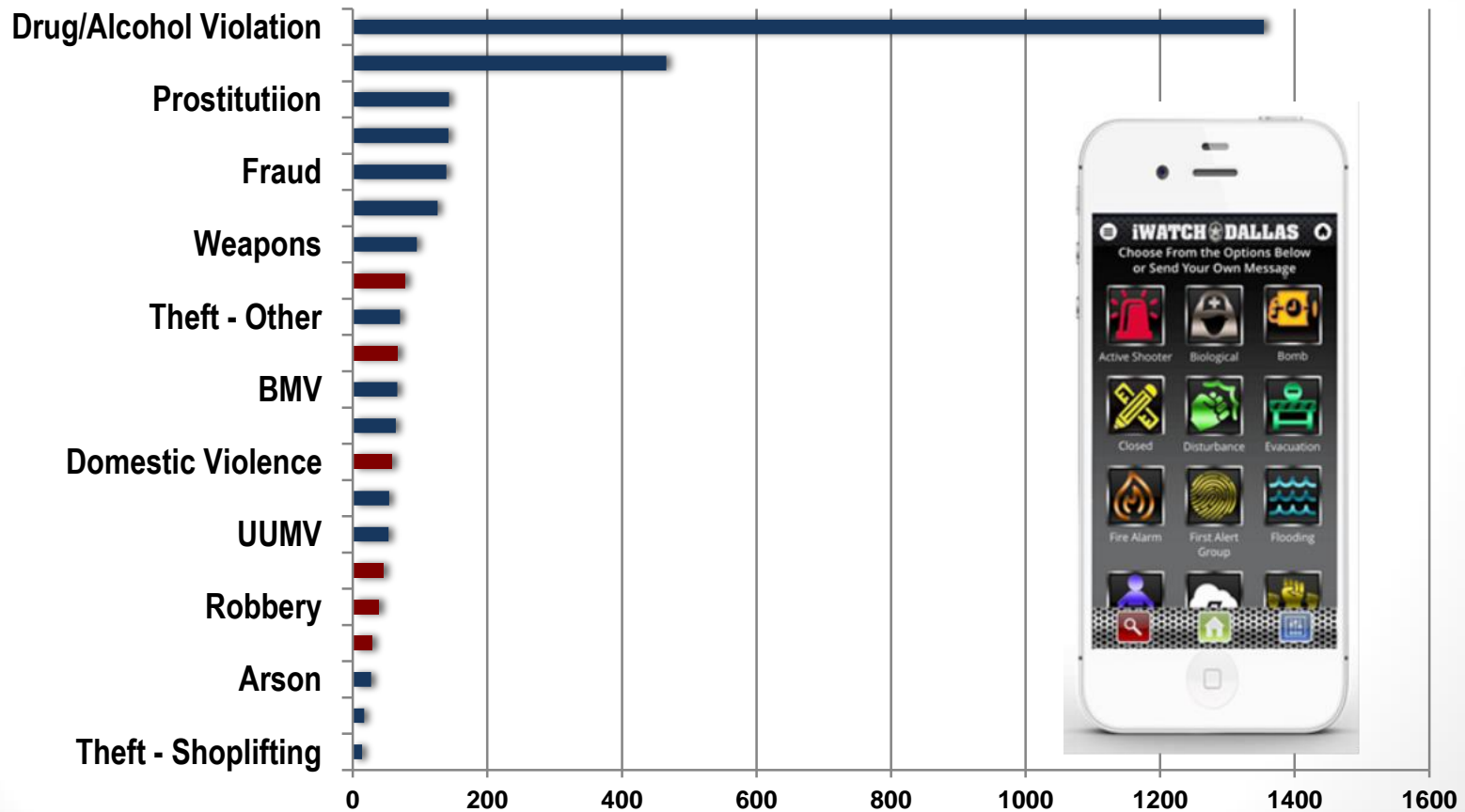

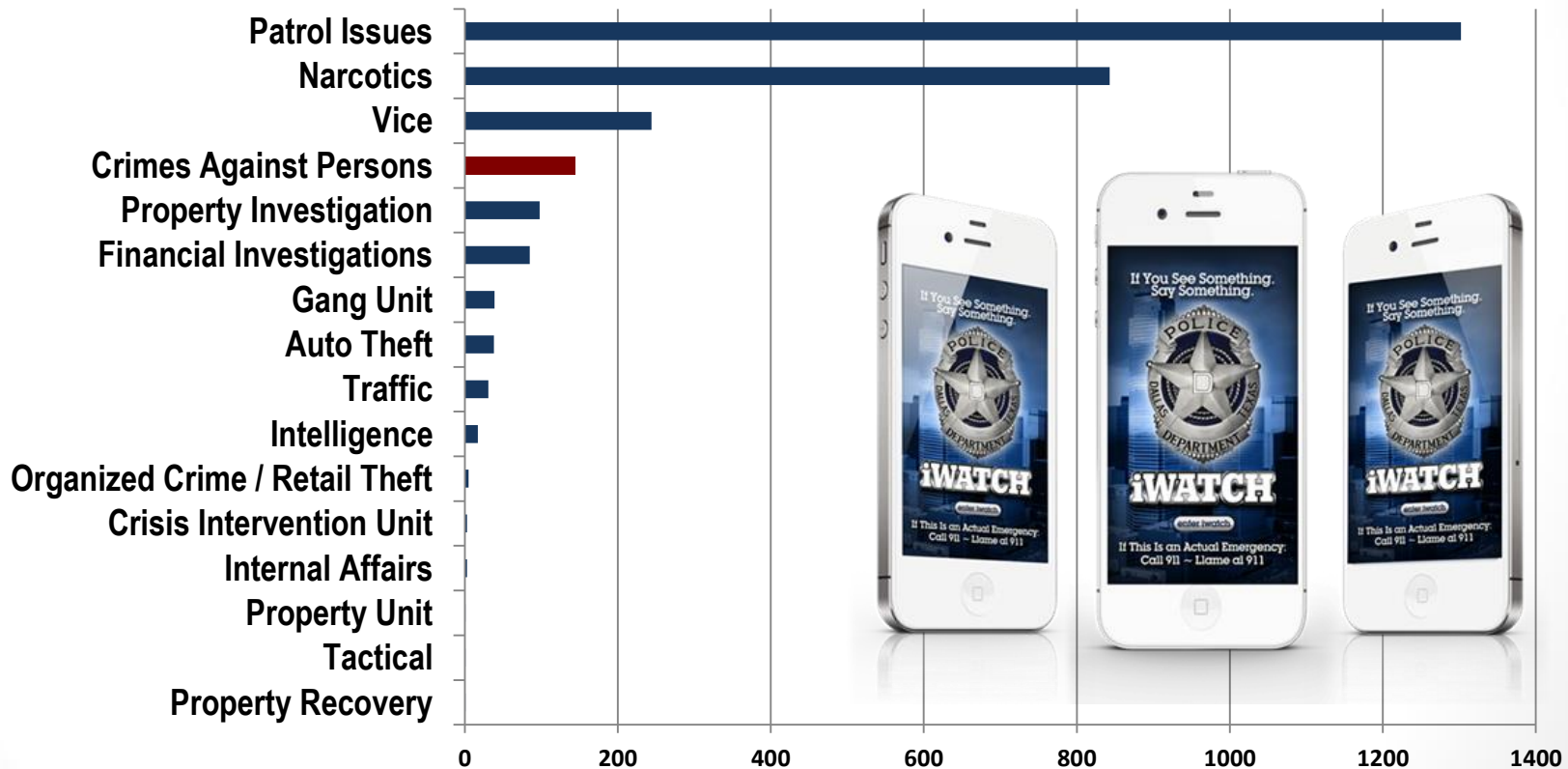
Tips by Crime Type

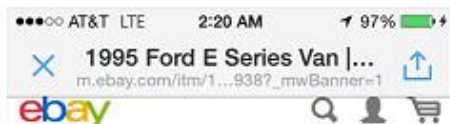



In 2007 Dallas County entered into a collaborative partnership with the Texas Conference of Urban Counties to develop an integrated information management system to share information with participating local governments. This program allows adult cases to be filed electronically. Benefits from the system include: more expedient case filing, reduction of paper use, and easier more efficient accountability. The electronic cases can be transferred to Internal Departments and External Law Enforcement Agencies for recording and tracking purposes.

The MOU outlines what is required by Dallas Police Department to utilize the system. The new system will do everything the current system is capable of doing, but it has been upgraded and has expanded the capabilities of sharing of information with other law enforcement agencies and county agencies.

A grant application was submitted by the due date on May 22, 2015, by the Dallas Police Department seeking grant funds from the Texas Burglary and Automobile Theft Prevention Authority (ABTPA) in a competitive state-wide grant application process. On July 17, 2015, the Dallas Police Department was awarded \$555,204 by the ABTPA. The total estimated project cost is \$1,183,639, which consist of:

ABTPA Award: \$555,204
Grantee Cash Match: \$111,041
Grantee in-Kind Match: \$517,394
Total Project Cost: \$1,183,639

The grant period will be from September 1, 2015, through August 31, 2016.

Once accepted these monies will provide funding for the police department's continued mission of auto theft prevention, increased public awareness and education, and the apprehension and identification of auto theft offenders. The number of personnel funded by the grant is seven.

The Texas Department of Transportation has awarded \$999,945 for the Comprehensive STEP (Selective Enforcement Program) Grant to the Traffic Section of the Dallas Police Department FY 2015-16. The grant requires the City of Dallas to provide a match of \$273,534 in the way of pension contributions. The total grant awarded to the City of Dallas \$1,273,478.

The grant provides for the reimbursement of travel expenses and overtime salaries for officers and supervisors to take enforcement action on specific violations: driving while intoxicated (DWI), speeding, occupant restraint and disregarding traffic control devices in the City of Dallas. The STEP grant is part of the national traffic safety plan from the National Highway Traffic Safety Administration and is intended to reduce the number of injury and fatality crashes. The major contributors to most fatal crashes are alcohol use, non-use of occupant restraints, speeding and disregarding traffic control devices. The Dallas Police Department has utilized grant funding as part of its overall traffic safety plan for many years.

The Dallas Police Department is seeking the support and recommendation from the Public Safety Committee to accept the Dallas Police Department Selective Traffic Enforcement Program (STEP) Grant. This item will be placed on the August 26, 2015 City Council Agenda.

The City of Dallas has been awarded funding in the amount of \$65,025 for the 2015/2016 Tobacco Enforcement grant from the Texas School Safety Center at Texas State University. This will provide the Dallas Police Department Vice unit additional resources for the period of September 1, 2015 through August 31, 2016. The grant amount is \$65,025, and no local match is required.

This grant was created to enforce Subchapter H, Chapter 161, Texas Health and Safety Code, to reduce the extent to which cigarettes and tobacco products are sold and distributed to persons younger than 18 years of age. The grant will provide funding for the overtime salaries of Vice personnel who will be conducting controlled buys and stings, and enforcement of minor in possession. Additionally, the grant will fund the payment of confidential informants used in controlled buys and for purchases of tobacco products by these informants.

The Dallas Police Department is seeking the support and recommendation from the Public Safety Committee to accept the Tobacco Enforcement Grant. This item will be placed on the August 26, 2015 City Council Agenda.

The Dallas Police Department seeks approval to receive reimbursement for overtime from Federal and State Law Enforcement agencies for task force investigations, in an amount not to exceed \$600,000. A city match of \$173,700 for pension and FICA is funded in the FY15-16 budget.

The Dallas Police Department is routinely asked to participate in 18 to 25 various federal and state law enforcement investigation task forces per year. Each task force investigation is usually confidential in nature, and the officers are given undercover assignments.

The Police Department seeks authorization to receive reimbursement for expenses associated with task forces from sponsoring federal or state agency involved. The reimbursed expenses are generally for officers' overtime associated with the investigations. Occasionally, the task force agreement specifies reimbursement for other miscellaneous expenses, such as equipment.

The Dallas Police Department is seeking the support and recommendation from the Public Safety Committee to authorize reimbursement of overtime for Federal and State Law Enforcement agencies task force investigations. This item will be placed on the August 26, 2015 City Council Agenda.

The City of Dallas is seeking authorization for a two-year renewal of the contract with Dallas County Community College District, El Centro College for instructional services related to police academy training. The City will receive up to \$400,548 for academy training program instructional hours provided during September 1, 2015 through August 31, 2017.

The Texas Higher Education Coordinating Board in coordination with the Dallas County Community College Districts' Community Service Program will pay \$19.24 to the City of Dallas for each certifiable instructional hour provided for basic training to recruits (regular and reserve) and for in-service training to veteran personnel. The City will also receive \$11.10 for each certifiable instructional hour for instructional support related to: training outside agencies, Citizen Police Academy training four (4) times per year, and staff development for certified instructors. Payments received from El Centro College will be used by the Police Department for instructional and administrative costs in support of the academy training program.

The Dallas Police Department is seeking the support and recommendation from the Public Safety Committee to renew a contract with Dallas County Community College District, El Centro College for instructional services for police academy training. SUBJECT: **Upcoming Agenda Item on the September 22, 2015 Council Agenda – Lew Sterrett Jail Contract**

Under agreement by resolution, Dallas County has provided jail services for City of Dallas prisoners since 1978. Jail services include administration, intake, housing and release. The original contract agreement has been amended four times, most recently in 1997, and is brought before Council on an annual basis to consider authorization of payment for upcoming fiscal year costs.

On September 22, 2015, City Council will consider an agenda item to authorize payment to Dallas County under the Lew Sterrett Jail contract for FY 2015-16. The proposed amount is \$7,557,391, or \$425,751 less than the current FY 2014-15 contract.

Calculated costs are reviewed annually and based on projected prisoner intake, housing counts and indirect costs. The FY 2015-16 Lew Sterrett Jail costs reflect projected City of Dallas usage at 19,453 prisoners processed at intake, and 8,418 days' worth of prisoner housing. As prisoner intake and housing numbers fluctuate, prorated Lew Sterrett Jail costs are adjusted for the City and other entities who utilize the facility.

Dallas County's FY 2015-16 daily per prisoner housing cost will increase by 10% over the current year contract. To contextualize the County's prisoner housing proposal, an analysis was recently undertaken using data from the *Texas Commission on Jail Standards* or *T.C.J.S.* On a monthly basis the *T.C.J.S.* issues a standardized report which compares the cost per prisoner housed for all Texas counties. Excluding indirect costs and measuring Dallas County's total number of beds, they list Dallas County's average daily housing cost to be \$63.11 per prisoner. In their most recent June 2015 report, the *T.C.J.S.* calculates the statewide average for Texas county jails to be \$60.29 per prisoner housed. The cost for Texas' five largest counties is as follows: Harris, \$75; Dallas, \$63; Tarrant, \$38; Bexar, \$46; and Travis, \$114.

The Court & Detention Services Department is seeking the support and recommendation from the Public Safety Committee to authorize payment to Dallas County under the Lew Sterrett Jail contract for FY 2015-16. This item will be placed on the September 22, 2015 City Council Agenda.

On June 13, 2015, at approximately 12:20 a.m., the suspect parked an armored van outside Jack Evans Police Headquarters located at 1400 S. Lamar Street. While parked in front of headquarters, the suspect fired an automatic rifle into the lobby before engaging responding officers in a gunfight. The suspect then fled the location at which time a vehicle pursuit ensued. Responding officers pursued the suspect who stopped his vehicle on a business parking lot in Hutchins, Texas. A second gunfight occurred between the suspect and the pursuing officers. After a standoff with the suspect, a Tactical sniper shot the suspect. The suspect was pronounced deceased at the scene. No officers were injured during the encounters.

On July 7, 2015, detectives assigned to the Crimes Against Persons Division received a tip from Crime Stoppers regarding the suspect, who is a registered sex offender, tutoring a 16-year-old male every day around noon. The detectives did research on the suspect and discovered he had an active parole violation. The detectives contacted Officers #1, #2, #3 and #4, who were in full police uniforms and driving marked police vehicles, to assist with the arrest of the suspect. The detectives met with Officers #1, #2, #3 and #4 prior to going to the suspect's residence to formulate a plan. The detectives, who were in plain clothes and driving an unmarked vehicle, drove to the suspect's residence. When the detectives arrived at the location, they observed the suspect walking outside. The detectives followed the suspect and notified Involved Officers #1, #2, #3, and #4. The suspect walked to the bus stop in the 1100 block of North Bishop Street. At this point, Involved Officers #1, #2, #3 and #4 made contact

with the suspect. The suspect, who was wearing a suit, reached in his jacket and produced a revolver. Involved Officers #1, #2, #3 and #4 ordered the suspect to drop the weapon. The suspect made a gesture with the weapon forcing Involved Officers #1, #2, #3 and #4 to discharge their weapons. The suspect was struck and was pronounced deceased at the scene. No officers were injured.

On June 14, 2014, at approximately 11:25 a.m., Officers #1 and #2, in full police uniforms and driving a marked police vehicle, responded to a Signal 46 (Major Disturbance CIT Mental Illness) call at 208 Glencarin Drive. The witness, who is the suspect's mother, called 9-1-1 and stated her son was bipolar and schizophrenic and he was possibly off his medication. The witness also stated the suspect was arguing and needed to go to Parkland Hospital. When the officers arrived at the location, there were three vehicles parked in the driveway of the residence and the front door opened facing the driveway. Officers #1 and #2 approached and knocked on the front door at which time the witness opened the door and stepped out onto the small raised porch area. The witness informed the officers that the suspect was making disturbing remarks. The suspect who had followed the witness onto the porch had a screwdriver in his right hand. Both officers gave the suspect loud verbal commands to drop the screwdriver. The suspect did not comply with the officers' commands and made an aggressive act towards Officer #1 with the screwdriver. Officers #1 and #2, in fear of their lives, drew their weapons and fired at the suspect striking him multiple times. The suspect was pronounced deceased at the scene by Dallas Fire and Rescue #40. No officers were injured during this incident.

UPDATE: The Internal Affairs Division investigation revealed the officers were justified in their use of deadly force.
