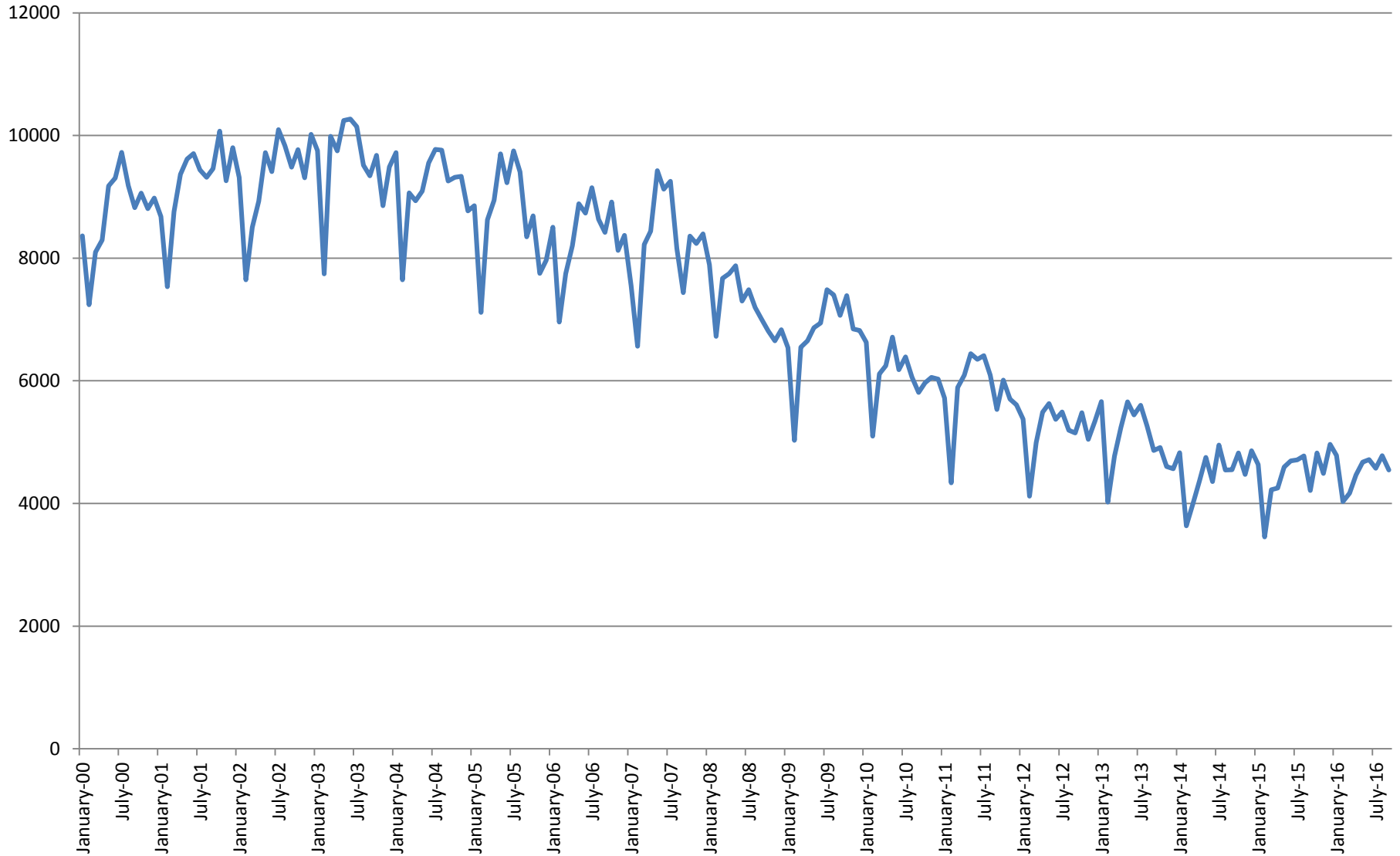

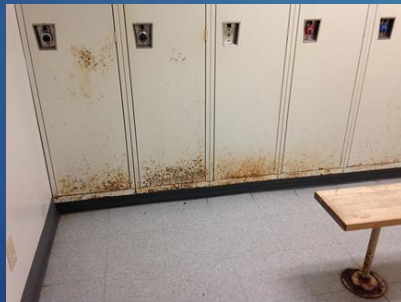

# Accomplishments: Co-Op Meeting

- Monthly SAFE Co-Op Meeting
  - Includes members from each prong of the SAFE process (DPD, DFR, Code, CAO)
  - Goals Include:
    - Discuss strategies to achieve compliance from property owners
    - Discuss possible litigation locations
    - Continuous assessment of the SAFE process to determine which practices work/don't work

# Accomplishments:

## Escalated Accord Meeting

- Implemented an accord meeting checklist to ensure all divisions were conducting meetings in the same fashion
- A representative from the city attorney's office will be present during accord meetings with owners/representatives of properties that have reached an **escalated** status due to non-compliance and may be present for non-escalated properties

# Accomplishments: SAFE Prime

- A SAFE property will be considered “Prime” if it meets one or more of the following criteria
  - No significant crime reduction and abatement of code/fire violations within a four month period
  - Properties located in a TAAG and Neighborhood Plus/Neighbor Up area (Properties located only in a TAAG will be considered for higher prioritization)
  - Properties with a past due Graded Inspection (GI)

# Accomplishments: SAFE Prime

- The following steps will be taken on all SAFE Prime properties:
  - Contact with property owner/representative every two weeks to obtain status update
  - Second accord meeting to include a representative from the city attorney's office for escalated cases
  - Refer to city attorney's office if there is no progress after 30 days of escalation status

# Accomplishments: Exit Transition Meeting

- Criteria for transition from SAFE:
  - 120 days of monitoring (multi-family)
  - 90 days of monitoring (single family)
  - Abatable crime significantly reduced
  - Life hazard violations corrected
- SAFE Team and General Code will meet with property owners to discuss continued progress on outstanding code violations
- The SAFE case will be closed and will transfer to General Code or Community Prosecution

# Accomplishments:

## Partnership with General Code

- SAFE Code inspectors will notify the multi-family section of all new multi-family SAFE cases to determine status of Graded Inspection (GI)
- If GI is overdue a multi-family inspector will accompany the SAFE detective during the initial inspection to perform the GI inspection
- SAFE Code Inspectors attended a training on June 7-9, 2016 to receive additional training in Structure Inspections and get familiar with the Multi-family Graded Inspection (GI) procedures.



# Accomplishments:

## Partnership with General Code

- From March – April 2016, a pilot of dual inspections for GI and SAFE was conducted on priority cases in District 10
- April 2016 to present, the SAFE/ GI program is in full swing
- Weekly GI Inspections are performed on all divisions
- Thirty-three (33) SAFE/GI Inspections have been conducted since April 2016 to present
- 17 passed and 16 have failed

# Accomplishments: Dedicated Docket

- Citations written by SAFE team members are now being placed on the Housing or Environmental Docket in Court 11
  - One group of prosecutors to ensure uniformity
- The municipal citation list was reviewed and no updates were needed. Code and Fire Inspectors ensure citations issued coincide with existing offense codes and proper verbiage

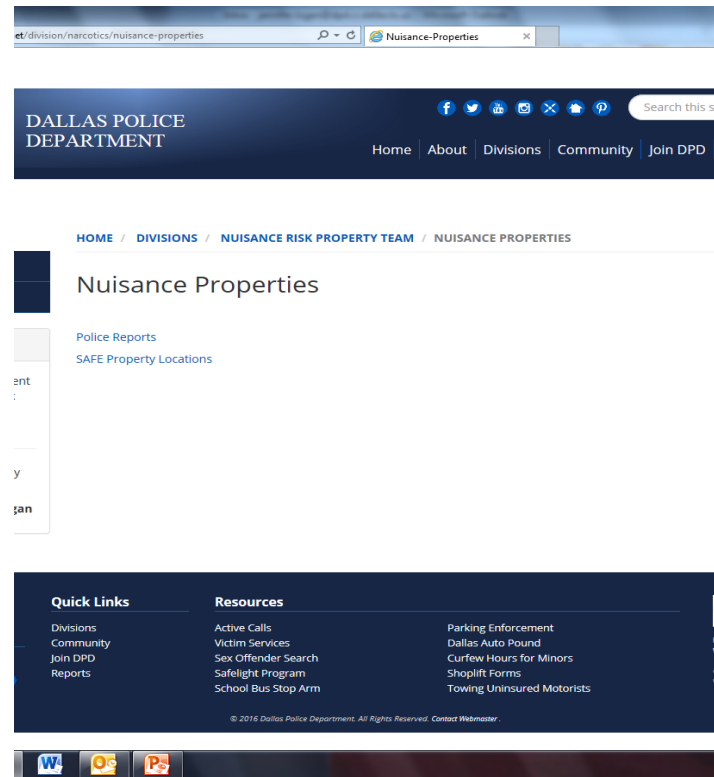



In October of 2016, the Department of Homeland Security announced its grant funding for the 2016 award year. As a designated recipient of this funding, the City of Dallas has applied for and been awarded \$5,787,075.50 to build our capacity to prevent, protect against, respond to, and recover from a terrorist attack or natural disaster. There is no local match requirement for this grant.

The Homeland Security Grant Program (HSGP) is comprised of several grant programs and we generally receive awards under two of those categories, the Urban Areas Security Initiative (UASI) and the State Homeland Security Program (SHSP). This year we were solely awarded through the UASI funding stream. Together, these grants fund a range of preparedness activities, including planning, salaries, equipment purchase, training, exercises, and management and administration costs.

Under UASI, the City of Dallas has been awarded \$5,787,075.50. UASI focuses on the unique planning, equipment, training, and exercise needs of high-threat, high-density urban areas, with specific carve outs for Law Enforcement activities and Management and Administration of the grant. It assists us in building sustainable capacity to prevent, protect, respond, and recover from acts of terrorism.

This award will be used to fund:

- Enhancements to the City's communications systems
- Law Enforcement Training and Equipment enhancements
- Equipment and Maintenance for the Dallas Fire Department's US&R and HazMat teams
- Security Enhancements for Jack Evans Police Headquarters
- Enhancements to the City's Emergency Operations Center
- Planning, training and exercise of emergency management and first responder personnel

From 2003 - 2015, the Department of Homeland Security has awarded the City of Dallas over \$90 million in grant funds under the Homeland Security Grant Program. These funds are awarded based on an analysis of a region's risk level and the effectiveness of the grant application.

The Office of Emergency Management is seeking the support and recommendation from the Public Safety Committee to authorize the acceptance of this 2016 Homeland Security Grant. This item will be placed on the November 9, 2016, City Council Agenda.

The City of Dallas has been awarded continuation funding in the amount of \$488,767 for the Internet Crimes Against Children (ICAC) Program from the U.S. Department of Justice, Office of Juvenile Justice and Delinquency Prevention, Grant award 2016-MC-FX-K034. In this grant award, \$167,000 is also awarded for cooperative working agreements.

The grant will pay full salary and benefits for two Police detectives, equipment, travel/training, and expenses for the Dallas Police Department's ICAC Squad. This grant will also provide funding for the District Attorney's Offices in Dallas, Tarrant and Potter Counties; and the Collin County, Taylor County and Wichita County Sheriff's Offices; and the Police Department in the Cities of Lubbock, Abilene, Amarillo, Fort Worth, Arlington, Garland, and Longview. All the funds will be for each agency to use on equipment, training, undercover expenses, and overtime as related to their Internet Crimes Against Children efforts.

This grant will also provide funding for the Dallas Children's Advocacy Center to sponsor scholarships for smaller agencies that normally would not be able to send representative to the 2017 Crimes Against Children Conference to be held in Dallas.

The Dallas Police Department is seeking the support and recommendation from the Public Safety Committee to accept the City of Dallas – 2017 Internet Crimes Against Children Continuation Grant and approve cooperative working agreements. The City is looking for both items to be considered together on the Agenda. These items will be placed on the November 9, 2016, City Council Agenda.

SUBJECT: **Upcoming Draft Agenda Item H: Authorize (1) an application for and acceptance of the Office of Community Oriented Policing Services Hiring Program Grant from the U.S. Department of Justice for the hiring of twenty five police officers in the amount of \$3,125,000 over a three-year grant period from September 1, 2016 through August 31, 2019; (2) a local match in the amount of \$1,909,268; (3) add twenty five (25) police officer positions; and (4) execution of the grant agreement - Total not to exceed \$5,034,268**

The Office of Community Oriented Policing Services (COPS) Hiring Program Grant is a competitive salary reimbursement program that provides funding directly to law enforcement agencies having primary law enforcement authority to create and preserve jobs and to increase their community policing capacity and crime-prevention efforts.

The City of Dallas has been awarded twenty-five (25) new officer positions, for a total grant amount of \$3,125,000. This is the maximum amount that could be awarded under the 2016 grant. The City of Dallas will provide \$1,909,268 in matching funds, for a 38% overall match. The City provides 22% of the match for year one and the match progressively increases to 43% for year three. After the three-year award period, the positions will be 100% funded by the City of Dallas, and must be maintained for at least twelve months.

The Dallas Police Department is seeking the support and recommendation from the Public Safety Committee for the acceptance of the FY 16-17 COPS Hiring Program Grant. This item will be placed on the November 9, 2016, City Council Agenda.

SUBJECT: **Upcoming Draft Agenda Item I: Authorize (1) an amendment to the interlocal contract between City of Dallas and Dallas County Community College District (dba El Centro College) to ensure corresponding reimbursement to the City to modify the clauses of the original contract and increase total appropriation in amount not to exceed \$75,000 from \$400,548 to \$475,548, for the two-year period September 1, 2015 through August 31, 2017; and (2) make payment to Dallas County Community College District (dba El Centro College) for the tuition costs of the officers that attend these classes in an amount not to exceed \$75,000**

The City of Dallas contract with the Dallas County Community College District (DCCCD) on behalf of El Centro College has been amended by modifications of the clauses within the original contract. The Texas Higher Education Coordinating Board reimburses public colleges and universities for a percentage of classroom instruction and supplies provided by Dallas Police Officers. In partnership with the City of Dallas, El Centro College has reimbursed the City for certifiable instructional hours for the past 40 years.

Recent clarifications to the policies governing the eligibility for acquiring these funds has determined that only tuition based courses are eligible for reimbursement. Per the modifications of the contract, the City will be paid an increase from \$19.24 to \$26.44 from the College for each certifiable instructional hour the Police Department provides. The College's total payment to the City for the duration of this Contract will increase \$75,000. The College shall invoice the City quarterly tuition at a rate of \$5.00 per student enrollment for In-Service Training classes and \$25.00 per student for each section of the basic peace officer academy not to exceed \$125.00 per participant. The total tuition amount shall not exceed \$75,000.

The Dallas Police Department is seeking the support and recommendation from the Public Safety Committee to authorize this amendment to the current interlocal agreement between City of Dallas and DCCCD (dba El Centro College) to reflect changes in the reimbursement policy for instructional services under this contract. This item has been placed on the agenda for the November 9, 2016, City Council meeting.

SUBJECT: **Upcoming *Draft Addendum Item J: Authorize a Memorandum of Understanding (MOU) between the City of Dallas and the Society for the Prevention of Cruelty of Animals (SPCA) of Texas authorizing the SPCA to provide investigative follow-up for offenses reported as Cruelty to Non-Livestock Animals as specified under the Texas Penal Code Chapter 42.092 – No Cost Consideration to the City***

The Dallas Police Department (DPD) responds to and investigates approximately 300 offenses per year that are classified in the Texas Penal Code 42.092 as Cruelty to Non-Livestock Animals. Currently, these offenses are assigned to DPD property crimes detectives assigned to patrol stations for follow-up.

The MOU will allow the SPCA to provide investigative follow-up and case filing with the Dallas County District Attorney as needed for all Cruelty to Non-Livestock Animal cases at no cost to the City. The SPCA will provide a licensed peace officer commissioned by the Dallas County District Attorney's Office who is trained specifically to investigate and file cases of animal cruelty. The SPCA special investigator assigned to the Dallas County Criminal District Attorney's Office will be responsible for investigations of alleged animal cruelty reported to the Dallas Police Department. The DPD will maintain overall control of the responsibility of reporting Animal Cruelty Offenses to the Texas Department of Public Safety, Uniform Crime Reporting Team, and will include all offenses and investigative findings reported to Dallas Police and investigated by SPCA investigators.

The Dallas Police Department is seeking the support and recommendation from the Public Safety Committee to accept this MOU. The item will be placed on the November 9, 2016, City Council Addendum.
