- Select 6 nominees for appointment to the 2017-2019 full term (Begin July 1, 2017 and end June 30, 2019).
 - o From these 6, identify who will be the shared member with the City of Cockrell Hill and represent the transportation disadvantaged.

Information on these nominees will be delivered to your offices on Monday, June 5, 2017. Formal appointments by the City Council are scheduled for Wednesday, June 21, 2017.

DART Board Nominee Interview Process

(Proposed)

- Nominees have been instructed to arrive at the City Secretary's Office prior to their assigned interview time.
 - o Each group will be escorted to the Green Room five minutes prior to the group's start time.
 - Although grouped, nominees will still be interviewed one at a time.

- At the time the DART Board Interview item is presented, by groups, the nominees will be invited to sit at the staff table and provide a brief introduction, after which
 - o First interviewee of Group 1 will remain at the staff table.
 - Remaining nominees will be escorted to the "Green Room" by CSO staff.
 - Following each interview, nominees will be given the option of:
 - Staying for the remainder of the meeting (item) and seated in the public gallery; or
 - Departing.
 - o Interviews continue for each member of a group.
 - Process repeats for Groups 2 through 4.

COMMITTEE ACTION(S) FOLLOWING INTERVIEWS

Step 1

- Deliberate the merits of each nominee.
- Ballots containing the names of all nominees (barring any last-minute cancellations) will be distributed to each Committee member who will select 7 nominees.
 - At this point, term assignment does not apply.
 - The meeting continues with deliberation of other agenda items as ballot results are being computed and additional ballots are being prepared.
 - Results are provided to Chair Kleinman to announce the results and additional balloting, if applicable.
 - To be considered as a finalist (top 7), a nominee must receive a majority vote of the Committee.
 - Balloting will continue until at least 7 nominees have been selected by a majority ballot vote of the Committee.
 - In the event of a tie, additional ballot vote will be required.

Note: Ballots may need to be customized depending on the results.

Step 2

- With Top 7 nominees selected, balloting continues to select:
 - Nominee to be recommended for (Position 01) for the 2016-2018 partial term (begins June 21, 2017 and ends June 30, 2018)
 - Ballots containing the names of the Top 7 nominees will be distributed to each Committee member who will select 1 nominee for recommended appointment to the 2016-2018 partial term.
 - Remaining 6 nominees are automatically recommended for appointment to the 2017-2019 full term (begin July 1, 2017 and end June 30, 2019).
 - Place assignments are not applicable for these nominees; the City Secretary's Office assigns
 place numbers following formal appointment by the City Council (scheduled for June 21).
 - Results are provided to Chair Kleinman to announce the results.

Step 3

- Ballots containing the names of the 6 nominees for the 2017-2019 full term will be distributed to select 1 nominee to:
 - Represent the Transportation Disadvantaged and be the shared member with the City of Cockrell Hill.
 - Results are provided to Chair Kleinman to announce the results and additional balloting, if applicable.
 - In the event of a tie vote among the nominees, the City Council will be given the option to select among those nominees.

Step 4

- Recap of results.
 - No further action from the Committee required.
 - City Secretary's Office will notify the City Council of the resulting recommendations.
 - City Council's formal appointment scheduled for June 21, 2017
 - The recommended finalists are not guaranteed appointment as the City Council can consider other nominees, but only if interviewed by the Committee.
